Co-ordination Programme for Joint European/International Doctorates

On May 19th 2009 the Academic Senate of Sapienza University of Rome has approved the foundation of a *Co-ordination Programme for Joint European/International Doctorates* – following the approvals of both the Doctorate Committee (on March 11th 2009) and International Relations Committee (April 1st 2009) - which will support this new organisational structure as a transversal action.

In addition to 156 doctorates and 17 Doctoral Schools including 102 doctoral programs and 1 National Doctoral School in collaboration with other Italian H.E. institutions, Sapienza University currently has the following 4 active International PhDs in various disciplinary and cross-disciplinary fields ranging from social sciences to neurosciences to physical-natural sciences:

- European PhD on Social Representations and Communication (1996)
- European PhD in Socio-Economic and Statistical Studies (2001)
- International PhD in Astrophysics (2003)
- European/International PhD in Cognitive, Social and Affective Neuroscience (2005)

Whereas the organisation of the Doctoral Schools of mono-disciplinary nature has been a reply to the fragmentation of the same discipline in many specialised courses, the implementation of the *Co-ordination Programme for Joint European/International Doctorates* aims at achieving the following objectives:

- identify an organisational structure which will allow a comparison between specific institutional experiences (from a training, didactic, management and administrative point of view) of international *joint* doctorates;
- discuss the strengths and weaknesses of joint doctorates on the basis of concrete experiences already had in collaboration with institutional networks in different countries, such as the adoption of the Regulations established by Sapienza as well as in relation to existing Regulations and procedures in other countries and partner institutions;
- identify operational solutions, share good practices and adopt the best solutions to problems, in order to remove specific obstacles that can emerge during the different phases of project conception, implementation, development and sustainability of international joint programmes. In particular, the following procedures will be compared and optimized:
 - candidate selection;
 - training structure and strategies to restrict the number of admissions;
 - research activity and training in an international environment;
 - intensive didactic "stages" (international summer schools) in multilingual and multicultural settings;
 - adoption of the European Credit System schema of structured training;
 - language policy and format for Ph.D. dissertation;
 - evaluation of the entire training process and quality system;
 - formal recognition of degrees and awarding of joint diplomas;
 - enhancement of the International/European doctor's career prospects both in and outside academia thanks to strong partnerships with private small-medium enterprise and public research centres.
- promote the harmonization of the most advanced cycles of education in Europe, in agreement with the recommendations of the *Bologna Process*, with the objectives established by the Lisbon Process for 2010 regarding the development of the *European Research Area*, and with the debate on doctoral training which has preceded and followed the 2003 Berlin Communiqué of the inter-governmental conference, until the formation of the European Doctoral Council (EUA-CDE) in 2008;
- identify transversal units of trans-disciplinary doctoral training, especially in the field of transferable skills, in order to experiment training solutions which are common to several international joint doctorates. This can be done by providing integrated seminars for research trainees currently attending courses in several disciplines, from social sciences to neurosciences to physical-natural sciences, thus optimizing the infrastructural and scientific resources of the various networks;
- identify interdisciplinary thematic areas of interest (as for ex. between the social and neuro-scientific domains of psychology, or between the socio-economical and the socio-psychological components, between quantitative and qualitative statistical and multi-methodological approaches in different disciplines) and organise intensive joint training in order to further develop doctoral training within the framework of the dialogue between scientific areas which are still too closed in a sectorial specialism;
- experiment and promote new forms of collaboration between international staffs of teachers and doctoral trainees belonging to different programmes with the goal to not only reproduce knowledge in the specific domains of academic research, but also to provide training that is open to innovation and is capable of understanding the complex problems that challenge the new frontiers of knowledge, also in the perspective of a research training useful in extra-academic contexts.























interests in Communication Studies, Sociology, Anthropology, History etc.) documented on the basis of the transcript of records and any other documentation on previous training.

They must have demonstrable advanced knowledge of English, and preferably another European language.

Applicants may be either:

- **post-graduates wishing to follow the international curriculum of the European/International Joint PhD Programme, rather than the national system;**
- **doctoral research trainees who are already engaged in a doctoral programme at their own university.** This is possible for candidates from countries where enrolment in two doctorates at the same time is permitted and on the condition that, once accepted, the research trainee will satisfy all extra requirements of the European/International Joint PhD, including as international mobility, thesis supervision by three tutors, active participation in the International Summer Schools and Lab Meetings, etc. in accordance with the European/International Joint PhD E.C.T.S. training structure and on the condition that the thesis developed within the European/International Joint PhD programme is an original piece of research and not the same thesis developed within the national doctorate being pursued at the same time. In the latter case the European/International Joint PhD constitutes an additional qualification.

Applications may be presented through the representatives of partner Universities, national tutors belonging to the European/International Joint PhD network, representative members of the So.Re.Com. THEMaticNETwork, or through tutors of doctoral programmes at the applicant's home university, if outside the European/International Joint PhD network. This will guarantee that applicants will be drawn from as wide a base as possible and not be recruited exclusively within the European/International Joint PhD multi-partner network.

Institutional Profile

The **European/International Joint Doctorate in Social Representations and Communication** (www.euophd.eu) represents a progressive educational curriculum for training early stage researchers through research in a cross-disciplinary paradigmatic field inspired by the Social Representations Theory and Communication studies. Although having a special focus in Social Psychology and media studies, it draws in a wide scientific community across continents and many disciplines dealing with social sciences and new trans-disciplinary thematic fields of studies focussed on "social issues".

The **European/International Doctorate in Social Representations and Communication** is a **EU-approved training structure** that since 1996 has been training post-graduates from EU and non-EU countries. It is a 3-year International doctorate requiring a PhD dissertation and involves a network of EU and extra-EU universities providing advanced research training in the area of social representations and communication.

The European/International Joint PhD came into being as a natural outgrowth of a pre-existing community of researchers working with the **Laboratoire Européen de Psychologie Sociale** (LEPS-FMSH) sharing similar research goals and epistemological interests. This common historical background greatly contributes to the complementary nature of the European/International Joint PhD's research interests and the training skills developed since its foundation.

The European/International Joint Doctorate in Social Representations and Communication is a well-established EU **consortium** (1993) of **24 universities: 17 universities in 10 European countries** (Austria AT, Switzerland CH, Czech Republic, CZ, Spain ES, France FR, Italy IT, Portugal PT, Romania RO, Slovakia SK, United Kingdom UK), institutionally linked to other **7 Universities in North America** (Canada and USA), in **Latin America** (Argentina, Brazil, Mexico) and in **China**, to **1 National Research Institute IFSTTAR** and the **Foundation for Social Sciences Maison des Sciences de l'Homme** in France, **1 multinational company in Netherlands**, and **2 small enterprises in Sweden and Italy** specialised in the field of communication, new media and distant interactive training via web.

Following a long history of institutional recognition started in 1993, Sapienza University of Rome is since 2013 the mono-contractor Institution coordinating the **So.Re.Com. Joint – Innovative Doctoral Program**, a EU-funded project evaluated as the best among the 1147 projects submitted within the **2013 People-ITN call** (with the highest mark 98,8/100).

The **Joint Degree** is awarded by a consortium of seven Universities in five European countries (**Italy, France, Romania, Czech Republic and Spain**) in cooperation with a wider institutional network of European Universities located in **Austria, France, Great Britain, Portugal, Slovakia and Switzerland**, and extra-European Universities located in **Argentina, Brazil, Canada, China, Mexico and USA**. Co-operation was established at the top institutional level on the basis of the **shared Regulations of the European/International Joint PhD in Social Representations and Communication**, signed by representatives of each partner university and an endorsement letter signed by the Rectors/President upon approval of the Regulation by the Academic Senates of the founding university, the University of Rome Sapienza (30-9-1996), I.S.C.T.E., Lisbon PT (27-3-1996). University of Helsinki (SF) (30-4-1996), University of Marseille I - FR (20-5-2005), and the University of Alexandru Ioan Cuza - RO (17-1-2006). These later were transformed into **Institutional Contracts** signed by all partner universities’ Rectors and the European Commission – and revised in the **International Agreement on Inter-University Cooperation** signed by the Rector/President of the University of Rome Sapienza ITALY (24-1-2007), University of Aix-Marseille I FRANCE (29-1-2007), Paul-Valéry University of Montpellier III FRANCE (11-01-2008), University Alexandru Ioan Cuza, Iasi ROMANIA (25-1-2007), Masaryk University, Brno, CZECH REPUBLIC (19-11-2007), Universidad del Pais Vasco, SPAIN (04-04-2014), Universitat de Valencia, SPAIN (24-11-2014) and in accordance with the Regulations on Doctorate approved by the Academic Senate of the founding university, the University of Rome Sapienza (24-10-2006). The extra-European Universities located in North America (Canada e USA), Latin America (Argentina, Brazil, Mexico) and Asia (China) and the non-Academic Partners are all members of the SoReComTHEmaticNETwork and are formally linked with the European/International Joint PhD in Social Representations and Communication on the basis of the Inter-institutional Agreements with the founding Sapienza University, also including staff and students mobility protocols, and of the endorsement letters within the **SoReComEuroPhD World Erasmus Mundus Programme** and within the **SoReCom Joint IDP Innovative Doctoral Program - People Initial Training Network Programme**. They ensure a wide range of complementary paradigmatic, methodological and thematic options offered by international and cross-sectoral research teams within and outside European borders.

The **European/International PhD in S.R. & C.** is co-ordinated since 1992 by the founding Sapienza University of Rome, site of the rapidly expanding **European/International Joint PhD Research Centre and Multimedia Lab**.

This European/International Doctorate is also sponsored by the French **Fondation Maison des Sciences de l’Homme** (Paris) and is formally linked with other universities around the world via the **So.Re.Com.THEmaticNETwork of excellence** (<http://www.euophd.eu/sorecomthenet-summary>). In addition, it collaborates with other **trans-disciplinary European networks** and with **companies** that actively participate in European projects or specialised in O.D.L., e.g. **EuroPACE**, to develop a collaborative Virtual European Virtual University, Multinational company **ELSEVIER B.V.**, Swedish company **CONERI**, Italian company **ContattoLavoro s.r.l.**, and French public research institute **IFSTTAR**.

By stressing the importance of improving the process of European cultural integration within a scientific context that is being increasingly oriented towards *internationalisation of training and research standards*, the European/International Joint PhD in Social Representations and Communication created under the above mentioned Erasmus-Socrates programme co-ordinated by the founding University of Rome Sapienza has been a *pioneer program* contributing since 1992 to the *overcoming of differences in national organisations of doctoral studies, both in terms of their regulations and financing, and in terms of curriculum quality*.

- Provide doctoral training in the field of Social Representations by structured training-through-research in an internationally recognised networked research environment. From the optic of social psychology, it offers a starting point for interdisciplinary dialog as well as an expert forum on the theoretical redefinition of problematic issues and methodological strategies within the specificities of different disciplinary approaches and their applicative value in different organizational and institutional contexts;
- Involve internationally recruited, trained, and monitored early-stage researchers in cooperative trans-national research led by a multigenerational community of scientists, to be catalysts for expertise both in and outside Europe;
- Promote European excellence beyond the boundaries of the European Union. The enlargement to partners from six extra-European countries (Argentina, Brazil, Canada, China, Mexico and USA) represents an effort to disseminate European excellence worldwide, beyond the EU's borders, in synergy with well-reputed scientists and research centres in some non-EU countries of great strategic value for the expansion of the scientific field led by European scientists. The goal is to attract the best early-stage researchers from abroad, encouraging them to undertake their research training in Europe, also in view of closer integration of the European employment market, thus rendering our private sector much stronger in this period of globalization and high competition with extra-European companies.
- Offer integrated activities supporting international physical and virtual mobility for early-stage research fellows, International Summer Schools, International Lab Meetings, and international mobility for teaching staff.
- Directly and systematically incorporate a select number of small/medium private enterprises from different countries (France, Italy, Sweden) into the training activities.
- Make research careers more attractive via cooperation between academia, public research centres, and small and medium sized companies that have common research interests and complementary training activities;

Joint criteria have been developed, characterizing all planning, curricular, organisational, policy and procedural aspects essential for the design and implementation of the European/International Doctorate including:

- ♦ **candidate selection;**
- ♦ **training structure of participants from different nationalities;**
- ♦ **research activity and training in an international environment;**
- ♦ **intensive didactic “stages” in multilingual and multicultural settings;**
- ♦ **adoption of the European Credit System, according to a specifically designed schema of structured training;**
- ♦ **language policy and format for PhD dissertation;**
- ♦ **evaluation of the entire training process and quality system;**
- ♦ **formal recognition of the degree and award of joint diploma.**

Thematic Areas and Training Perspectives

The main thematic area of the European/International Doctorate in Social Representations and Communication and its related So.Re.Com. network of excellence is a paradigmatic area of Social Psychology inspired by the Social Representations Theory and Communication studies.

The Social Representations Theory is one of the 20th century's most important theories of the social construction of knowledge. The study of social representations, originally specifically European, is currently a multilingual, worldwide discipline with a substantial body of literature. It involves leading scholars from both social psychology and the social sciences: sociology, anthropology, education, economics, linguistics, semiotics and communication and media studies. Consequently, the program is open to multidisciplinary and multi-methodological research approaches (experimental and field work).

Studies of “what” people know - and “how” it relates to the social groups to which they belong and to the media - are concerned with the social construction and representation of a particular object (e.g. health-illness, environment, new technologies, politics, economics, European integration and enlargement, minority groups, immigrants and racism, human rights, etc.) and how its related scientific theories are transformed into everyday knowledge.

Of all the disciplines relating to communication studies (semiotics, linguistics, sociology, cognitive psychology, mass communication, symbolic anthropology, etc.) the European/International Joint PhD research training and the multi-year cycle of International Summer Schools focus primarily on social psychology, particularly in relation to social representations. The European/International Joint PhD's advanced research training thus involves key areas such as interaction, the media, the processes of social influence, languages, emotions and new contexts of virtual and mediated interaction. Within this framework, the

Because of the interdisciplinary training opportunities created by the intellectually advancing new generations of researchers, the scientific community of the European/International Joint PhD in Social Representations and Communication offers itself as a starting point for interdisciplinary dialog from optic of social psychology and, as well, an expert forum on the theoretical redefinition of problematic questions and methodological strategies within the specificities of different disciplinary approaches and their applicative value in different organizational and institutional contexts. The societal relevance of this field of study that crosses the borders of many disciplines also represents an added value.

Current Research Topics investigated by transnational research teams over the European Ph.D. institutional network

Since academic year 2009-2010, the European/International Joint PhD in Social Representations and Communication is structured in Research Teams on 13 main thematic areas and a larger number of specific sub-topics. This structure strengthens the scientific cooperation between the partners, and helps orienting the new candidates when presenting their research project proposal. Based on the expertise of our partners and complementarities of their offerings, in terms of both paradigmatic and methodological options and current research areas and sub-themes, we have assembled the following proposed research teams. The synergies created by working within these teams, composed of academic, public and private sector institutions and businesses provide research trainees with a much wider experience both in terms of methodologies and content. It is also an opportunity to explore employment possibilities outside of academia that they otherwise might not have considered. Didactic structure

The **European/International Doctorate in Social Representations and Communication** focuses on advanced training in the field of social representations and communication by developing:

- a) **theoretical and meta-theoretical knowledge,**
- b) **methodological expertise,**
- c) **fieldwork and applied value of the research,**
- d) **international networking and comparative research,**
- e) **transferable skills.**

The specific benefits of the training structure for European/International Joint PhD research trainees and the key didactic formula adopted consist of:

- Officialisation of the degree and mutual recognition of the *jointly awarded diploma*;
- **Greater access to expertise:** Access to leading experts on various continents (including the founder of the Social Representations Theory, who was also the Honorary Program Director) and collaboration with internationally recognised research teams and centres of excellence working on issues with strong societal relevance, where key factors for success include that the knowledge produced can be applied in organisational contexts in private companies and public research centres;
- Guaranteeing *European standards* both in terms of selection of successful candidates and the training they will receive in the programme.
- **Structured research training** in an international environment that enables trainees to expand their horizons;
- **Intensive didactic stages** in multicultural settings;
- **Multidisciplinary approaches** and the wealth of facilities at partner institutions to which trainees have access gives them far wider options for research than would be possible nationally. A *variety of methodological approaches* exposes trainees not only to a wide range of methodologies, but also to the leading experts in those methodologies. Trainees also benefit from the cultural/linguistic advantages of living and studying alongside trainees from other countries.
- **Tutoring and co-tutoring triadic system (multiple supervision):** Our unique tutoring system where research trainees are continually in contact with their tutors. Via the open distance learning system (ODL), tutors have on-line access to research trainees' work and monitor their progress speedily and directly. The programme guarantees a maximum of 2-3 trainees per tutor per year, ensuring constant individual and team tutoring and close monitoring of trainees' progress. Under the ODL, the Programme Director and the 3 tutors and co-tutors have access to trainees' research, advantageous because it enables the scientific committee to easily co-ordinate and supervise the training.
- **Interlocking structured system of virtual (open learning system) and physical international mobility of both research trainees and teaching staff.** **International mobility** is achieved both **at the individual and collective levels** by taking into account that international mobility is only a tool, not a goal in itself. It is just one of the requirements for a European doctorate, and in and of itself is not sufficient.
 - In the first case, individual research trainees are required to relocate abroad **to work in different countries and different research centres** at host institutions with which their tutors are associated and from whom they receive individual tutoring and co-tutoring for their research work. The international mobility will be planned jointly with the academic and/or non-academic partners depending on the research needs, of the collaborative research activities within the networked program involving the designated tutor and co-tutors. The duration and modalities of the abroad mobility will be defined case by case in agreement with the host institution on the basis of the scientific research training needs and of financial constraints..
 - In the second case, **collective mobility** involves all research trainees enrolled in the program and tutors from all the partner universities and is achieved during intensive stages, like the **International Summer Schools**, or the face-to-face sessions of **International Lab meetings**. To improve cross-fertilization of ideas and research practices, leading scientists and experts from outside the network are invited to teach and a limited number of post-doctorate researchers and research trainees from around the world enrolled in other doctoral programmes in related scientific fields are admitted as participants.
- Adequate *infrastructure and dedicated facilities* at the founding university and network universities, including a **common web site platform** that enables linkage between international physical and virtual mobility (access to a dedicated Portal and web-auditorium interactive system) and innovative practices adopted for teaching, tutoring and co-tutoring, network management, etc. that allow flexibility in face-to-face and open distance interactive learning contexts. The system of open distance learning guarantees meeting trainees' needs, enabling them to organise their research in the way they wish within the confines of the

didactic structure. Open distance learning as well as structured international mobility can also be adapted to provide temporary or more specific training where necessary.

- Transmission of **transferable general skills** (such as modern presentation techniques, conference presentation, workshop organisation, design and organization of academic work, research team management, and management of statistical software, large bibliographies and international databases, etc.) via *learning by doing*. This involves research trainees in scientific activities either individually or in small to medium teams and in different contexts (presenting their research progress during International Lab Meetings and Summer Schools, use of the web-auditorium, organising small seminars, participating in international conferences, advanced training courses for different statistical software packages, writing joint papers, participating in European projects and international networking, cooperating in meta-theoretical analysis of the specialised literature on Social Representations and Communication, managing a large bibliographical repository, contributing to the construction of the specialised *So.Re.Com.* "A.S. de Rosa's" @-Library, etc.). Within the framework of this fruitful inter-sectorial collaboration between academic and entrepreneurial network members, our enterprise partners have special responsibility for training in other transferable career skills, including: effective use of e-learning technologies, research software, web design, software programming, marketing, sales, management and entrepreneurship, etc.
- Participants in the programme will also benefit from the already consolidated international experience of European/International Joint PhD graduates who are members of the **SoReCom Alumni Network** and who have found employment not only at many European universities (Universitatea Dimitrie Cantemir of Bucharest, Transilvania University of Brasov, Cambridge, Eötvös University, Helsinki, University "A.I. Cuza", I.S.C.T.E. Lisbon, Liège, Lyon 2, London School of Economics, Nice Sophia-Antipolis, University of Sheffield, L.U.M.S.A., the Universities of Rome, Milan, Oslo, Pecs, Salerno, Tallin, Vienna, Salento etc.) but also in prestigious extra-European universities (Sarah Lawrence College, New York, UQUAM, University of Montreal, University of Ottawa, Jakarta University, the University of Tunis, Tianjin University of Technology and Education, Universidade Federal da Bahia, etc.), and in private foundations and companies (ADECCO, Danone, the Soros Foundation, Peugeot, and public or governmental institutions (Finnish Cultural Foundation; IFSTTAR – Institut français des sciences et technologies des transports, de l'aménagement et des réseaux – France; Sardinian Region Juvenile Court; Florence Employment Office; Center for Assistance Against Violence to Women « Differenza Donna », Thomson Reuters, International Union of Railways), etc.
- Financial support**, often a major factor in research trainees' ability to participate in training that involves mobility and "stages", allowing us to select the best applicants irrespective of their nationality and personal financial situation.

The didactic structure within this overall strategy is highly innovative. As the system of *open distance learning* makes clear, European/International Joint PhD research trainees are involved in an **interlocking structured system of virtual and physical mobility** which allows for considerable *flexibility* in catering to research trainees' needs while at the same time guaranteeing *individual tutoring* and *interactive learning*.

Due to the integrated and joint nature of the programme, the adoption of **European Credit System** has been specifically designed as a system for credit accumulation, rather than a comparison of distributed teaching offers and transfer of learning outcomes. By conceptualizing the academic year not exclusively in terms of time, but in terms of earned credits, the system allows for flexibly meeting the needs of full-time and part-time research trainees.

In line with the policy recommended by EU DG-Education and Culture, the European/International Joint PhD adopted the European Credit Transfer System (ECTS) as an instrument for creating transparency and confidence in academic performance.

Research trainees are awarded up to 60 credits per year (20 for courses and didactic activities and 40 for research quality and related bibliographic knowledge).

After selection, the national and two foreign tutors are responsible for the supervision of each PhD research trainee in all aspects of his/her training.

Once a candidate has been accepted, each successive year he/she must write an increasingly extensive report about the status of his/her research for approval by the national supervisor and the two foreign co-tutors. This report must be presented during the International Summer Schools and/or multi-point video-conferences in a public event that includes a forum discussion with the foreign supervisors and other international experts. To provide necessary feedback, research trainees complete evaluation sheets for scientific events such as the intensive training “stages” held during the International Summer Schools.

1. Intensive preliminary stage of bibliographic training at national universities (10 credits per year)

This is provided by individual tutoring by national and co-tutoring by foreign tutors as well as by access to an on-line database found on the European/International Joint Ph.D. web-site:

Research trainees are also trained by the Programme Director in meta-theoretical analysis of the bibliographic material in their own subject area. The contribution of each research trainee will thus enable the mapping out a complete, fully researched bibliography for social representations and communication.

2. Intensive high level didactic “stage” (International Summer School (10 credits per year)

Research trainees are required to attend the annual *European/International Joint Ph.D. International Summer School on Social Representations and Communication*. These international summer schools take place yearly and were hosted in one of the countries of the university network on a rotational basis until 1995. Since 1999 they have been held regularly at the co-ordinating University, Sapienza University, which has organised a series of 57 high level scientific training events (23 International Summer Schools and 34 International Lab Meetings).

3. Seminars and advanced courses (5 credits per year)

Research trainees must attend seminars and advanced courses held at the Research centre and Multimedia lab of the European/International PhD in Social Representations and Communication located at the co-ordinating university in Rome and at network university sites. These are planned in accordance with a teacher exchange mobility programme and include international guest experts.

4. Multi-media and open distance learning system; transferable skills (5 credits per year)

Research trainees are required to make interactive use of the open distance learning system. This is not only through asynchronous e-mail, but also by actively contributing to the dedicated European/International Joint PhD web auditorium, a multipoint interactive web-videoconferences integrated with forum discussion, and digital video-courses available on the web site of *the European/International PhD in Social Representations and Communication*, or multimedia tools on DVD support.

5. Tutoring and co-tutoring triadic didactic system (30 credits per year assigned to research)

The tutoring and co-tutoring triadic system is aimed at monitoring the development of research programmes at both national and foreign training sites over the entire period up to the final dissertation. Research trainees are assigned their own research “space” on the website in order to update their project and to allow supervision by national and foreign tutors and monitoring by the Programme Director and the Fellows’ Programme Coordinator.

Within this tutoring and co-tutoring triadic didactic system, research trainees are required:

- to spend at least 6 months conducting research in two different European countries. This unique feature of the European/International Joint PhD programme enables research trainees to work alongside their foreign tutors in a new and stimulating research environment. This training is characterised by a multidisciplinary and multi-method approach. Each network university site has special expertise in a particular methodological approach to research in social representations. The research trainee is thus exposed to a variety of complementary methodological approaches;
- to maintain regular communication with their national and foreign tutors. According to the circumstances, this can be in a face-to-face interactive and/or computer mediated communication context through the dedicated European/International Joint PhD web-auditorium, forum discussion and multipoint videoconferences;

- c) to attend courses and complete study and research activities in a timely fashion within the structures designed for that purpose, collaborating on institutional projects designated by the director of that structure and from the coordinating body of the doctoral programme. Doctoral candidates can participate in supplementary activities, such as seminars and tutoring, for a maximum of 40 hours annually. However, they cannot participate in commissions examining undergraduate candidates (laurea);
- d) to submit an extensive yearly report to be presented during a dedicated training session at the International Summer School and a critical review of the bibliography of research conducted;
- e) to write their dissertation in English or in the language of their main tutor (host institution). The national tutor and the two foreign co-tutors and two highly qualified academic evaluators must positively review the dissertation before it being discussed and evaluated by the International Evaluation Board of the Final Jury. In addition they must write a short version in English (or French, upon agreement of the Core Executive Committee) that will be evaluated by the International Evaluation Board of the Final Jury and must be presented in a format ready to be submitted to international journals (<http://www.euophd.eu/typologies-and-conventional-book-format-thesis>). In alternative to the “conventional” Thesis format, Research Trainees can adopt the "three papers" PhD thesis format.

Assessment tools used in the **open distance learning system** are of fundamental assistance in continuously monitoring the quality of training.

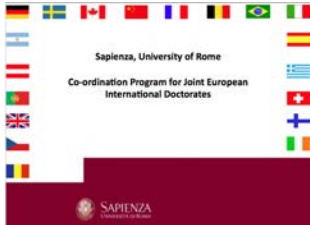
The Programme Director, in co-operation with the members of the Executive Committee and the tutors, evaluates the quality of the scientific and didactic content. This is accomplished using evaluative tools and co-tutoring, including distance co-tutoring that continuously monitors the research trainees' training via the European Doctorate's dedicated web site.

After monitoring the work of previous years, the Core Executive Committee decided to impose a more structured ‘time constraint’ on the development of research trainees’ programmes as another quality control procedure.

This offers tutors **on-line evaluation tools for various versions of the research trainees’ projects**:

- **Initial short version**
- **Intermediate extended version**
- **Final full report and short version**

These tools have been installed on the web site for every registered participant in the programme. They are considered confidential and are accessible for consultation only by those who have a password: the Programme Director, the 3 tutors (1 national + 2 foreign) and the research trainee him or herself.

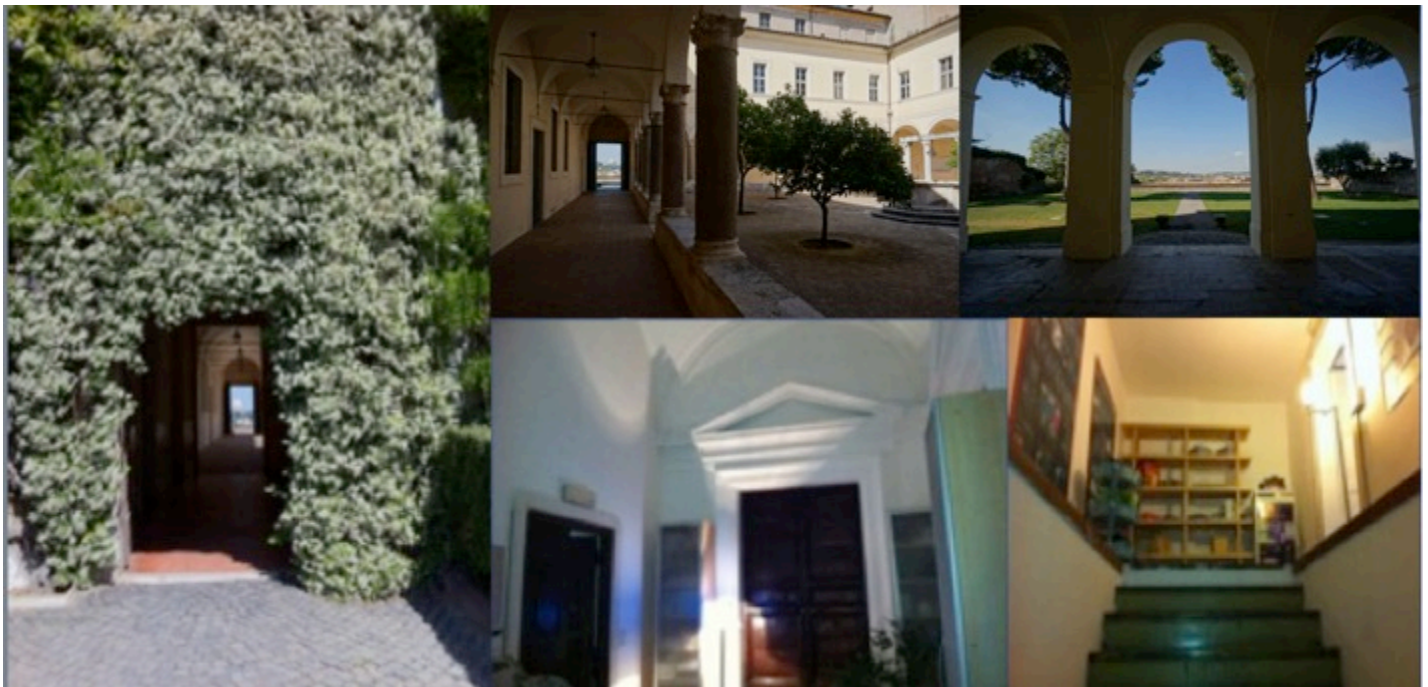

"A.S. de Rosa" @-library* has been transferred into an ad-hoc designed relational database implemented in 1996 on the *European/International Joint PhD in Social Representations and Communication* website (de Rosa, 2000, 2001, 2004 a, 2004 b, 2006; 2008; 2009 a, 2009 b; 2010 a, 2010 b, 2010 c; 2011; 2010 a, 2010 b; 2014; 2015a; 2015b; de Rosa, Picone, 2007).

It is built on an on-going multi-year project aimed at *an empirical meta-theoretical analysis of the whole literature on Social Representations* (de Rosa, A.S. 2013 a, 2013 b.; 2014; 2015a; 2015b). Guided by the main goal of evaluating *the impact of the scientific production driven by the Social Representations theory in the social arena faced with social demand*, the aim is to take stock of the scientific field developed in more than 50 years by conducting an empirical meta-theoretical analysis of the literature on Social Representations, mapping the development of different paradigms, the related research methods, the thematic areas and their impact on the various applied fields within the multi-generational community of scientists and across different geo-cultural contexts. This research program is led by de Rosa, creator and program director of both the *European/International Joint PhD in S.R. & C.* (<http://www.europhd.eu>) and the *So.Re.Com. THEmatic NETwork* (<http://www.europhd.eu/sorecomthenet-summary>), a "network of networks" that promotes co-operation between academic, professional research and commercial institutions and facilitates the dissemination of scientific results in the field of Social Representations.

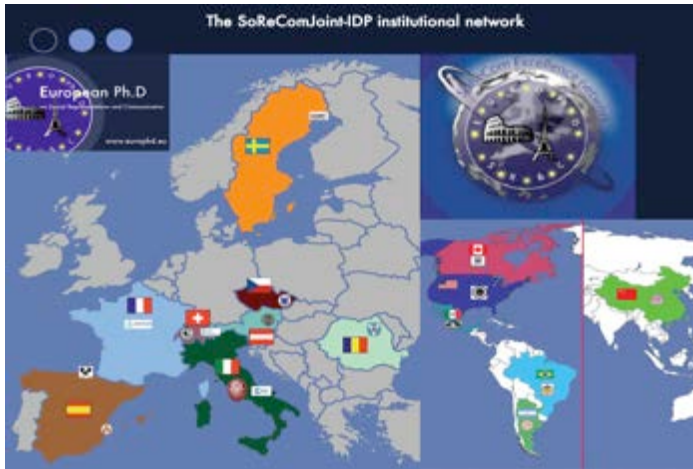

ON-GOING DEVELOPMENTS:

As on-going developments - whose realisation and implementation will be made possible thanks to the approval by the European Commission of the 2013-2017 contract SoReComJoint-IDP People-Innovative Doctoral Program positioned at the highest ranked (98,80/100 mark) among 1175 proposals - we envisage *from the content point of view*:

- a. an increased critical mass of content and related metadata of the the *So.Re.Com. “A.S. de Rosa” @-library* by the next four years -
- b. The So.Re.Com.Joint-IDP will contribute to disseminating also the meta-theoretical knowledge produced by a new team of 13 ESR who will work together, by access to the best comprehensive specialised @-library worldwide, on the on-going multi-faceted project led by the *European PhD Lab* director on top of previous multiyear work carried out with the long term purpose of writing a *Biography of the Social Representations Theory*. This unified research project framework will be articulated into 13 precise objectives concerning the specific research lines to be developed by each recruited ESR, matching their own interests and area of prior expertise. The ESR will cooperate in meta-theoretical analyses and contribute to the development of the specialised So.Re.Com. “A.S. de Rosa” @-library. The integrated research framework will provide an integrated training opportunity to maximise the cooperative and joint expertise of both the host institution and associated partners, doing so from the theoretical, methodological and applied perspective of the researches conducted in the 50-year development and diffusion of this scientific field, with a view to monitoring and exploiting its added value to respond to social demand in the multiple contexts of the social arena: from economics to the environment, politics, health and community issues, science communication, etc. The need for developing both

core and wider employment related skills is driven by the goal of making research training of greater relevance for a wider variety of careers both in and outside academia, internationally and globally more attractive.

- c. Driven by the synergic goal of an integrated development of the documentation tool “of” and “for” other researches (So.Re.Com. “A.S. de Rosa” @-library) and the training activities of the International doctoral program - among other multi-year series of activities, the *Winter Session International Lab Meeting* are specifically aimed at training in the *meta-theoretical analysis* of the specialized literature on S.R.: why and how to map the development of different paradigms, the related research methods, the thematic areas, their impact on the various applied fields and the new emerging research directions within the multi-generational community of scientists and across different geo-cultural contexts. The program includes:
 - *Key lecture* by the research leader, aimed at presenting the Meta-Theoretical analysis of complete body of the S.R. literature
 - *Presentations by So.Re.Com. Joint-IDP expert post-docs* and advanced doctoral trainees involving a *multigenerational community of senior and junior scientists* that ranges from visiting post-docs to Euro PhD Alumni (including former Marie Curie Fellows), already well trained in the *meta-theoretical analysis* of the specialized literature on Social Representations
 - *Training the ESR* for developing advanced bibliographic on-line search skills via access to other digital libraries, aimed at developing the large specialized full bibliographic *repository* and the So.Re.Com. “A.S. de Rosa” @-library
 - *Presenting guidelines* for integrating bibliographic resources in the physical and digital SoReCom specialised libraries
 - *Training the ESR in the meta-theoretical analysis grid* and tools of the meta-theoretical analysis *repository* including the following tasks and methodology. *Following guidelines and procedures given by the project leader prof. A.S. de Rosa and a specific training, the specific ESR's contribution consist:*
 - *to detect and retrieve publications not yet inserted in the So.Re.Com. “A.S. de Rosa” @-Library, and meta-analyse the whole body of the literature on Social Representations produced according to the “specific individual research focus” over the world and not only in the geo-cultural context/continent of the host institution for mobility stage;*
 - *to fill new information and upload the related PDF files into the specialized So.Re.Com. “A.S. de Rosa” @-Library;*
 - *to carry out statistical analyses on the complete meta-analysed body (extracted from the SoReCom “A.S. de Rosa” @-Library after the integration of the new information);*
 - *to produce video-interviews – according to an outline designed by the project leader - with the key scientists who contribute to the development of the paradigmatic approaches to Social Representations;*
 - *to fully describe, comment and visualize the results using de Rosa's Guidelines for the geo-cultural mapping in the PhD thesis in English (in the book format and short article).*
 - *Illustration of the double quality control system*
 - *Co-ordination and planning session* for the organization of weekly individual and group ESR small meetings on the transversal common tools of the overall research program and the specific goals of each of the research focuses.
- d. The complementary training stages at host institutions will also offer the ESR opportunities for networking and for further integrating physical and virtual international mobility.
- e. The supra-disciplinary, multi-methodological and thematic possibilities offered by the training network are enhanced the wide range of world-class visiting researchers invited to participate in the programme's intensive training "stages", multi-point videoconferences, tutoring and co-tutoring for individuals and small groups, and various on-line training tools.

Current developments *from the technical point of view*, are:

- a) ongoing transfer into a new web-platform from *web-object* to *Drupal*, expanding access via new web interfaces
- b) to implement a management service innovation enabling users to *virtually meet authors of the @-Library's content by jointly coordinated on demand meetings* between early stage researchers and famous authors belonging to the SoReCom scientific community

Briefly stated, the tools available at the European/International Joint PhD in Social Representations and Communication Research Centre and Multimedia Lab give us the possibility to have real time interactive exchanges with all our participants, our academic partner institutions, and experts around the globe providing a rich and ever-growing research and learning environment that is advantageous to research team members, trainees and experts alike.

The unique combination of a scientific network and a doctoral programme is, in fact, a multilingual and multicultural virtual campus where European research trainees and experts from academia and the public and private sectors come together to learn, share and create knowledge. The link between the SoReCom THEMatic NETWork Virtual Community and Virtual Campus insures that the

development of the integrated multimedia infrastructure is appropriate to content users' and producers' needs. Integrated with traditional face-to-face settings, the Virtual Campus exploits the web's potential as a co-operative learning space to train new generations of European/International Joint PhD in Social Representations and Communication research trainees.

This integrated face-to-face and open virtual space, accessible from anywhere in Europe or the world, not only meet the needs of its users by providing easy access to publications and metadata and many other kinds of digital multi-format documentation (printed, pictures, audio-videos), but also enables them to quickly become content providers and co-producers. The multigenerational nature of this interactive knowledge community guarantees cross-fertilisation of ideas between senior scientists and early research trainees, as well as between experts from within and outside of academic circles, including policy makers interested in research on societal issues and their relevance in social contexts. Therefore, open access to the integrated physical and virtual SoReCom THEmatic NETwork infrastructure will allow the members of this knowledge community to continue to grow. The newly designed web-service for enlarging interactive facilities of the *So.Re.Com. "A.S. de Rosa's" @-library* not only gives research trainees access to documentation, but in the physical and virtual space of this infrastructure also they can also meet authors and each other to discuss new publications and critical research areas.

All partners of the consortium offer laboratories specialised in different methodological approaches, for example: experimental approaches in Aix-En-Provence, Geneva, Vienna, Valencia and San Sebastian; field studies in Iasi, Brno, Nankai, Belgrano, Beijing; applied research in Montpellier, Vienna, Lisbon, Lausanne, Ottawa and so on. This is in addition to the integrated multi-method approach offered by the laboratory infrastructure at the coordinating University of Rome Sapienza.

Among them the Elsevier Infrastructures represents the most powerful IT infrastructure to run complex analyses, including High-Performance Computing Cluster (HPCC).

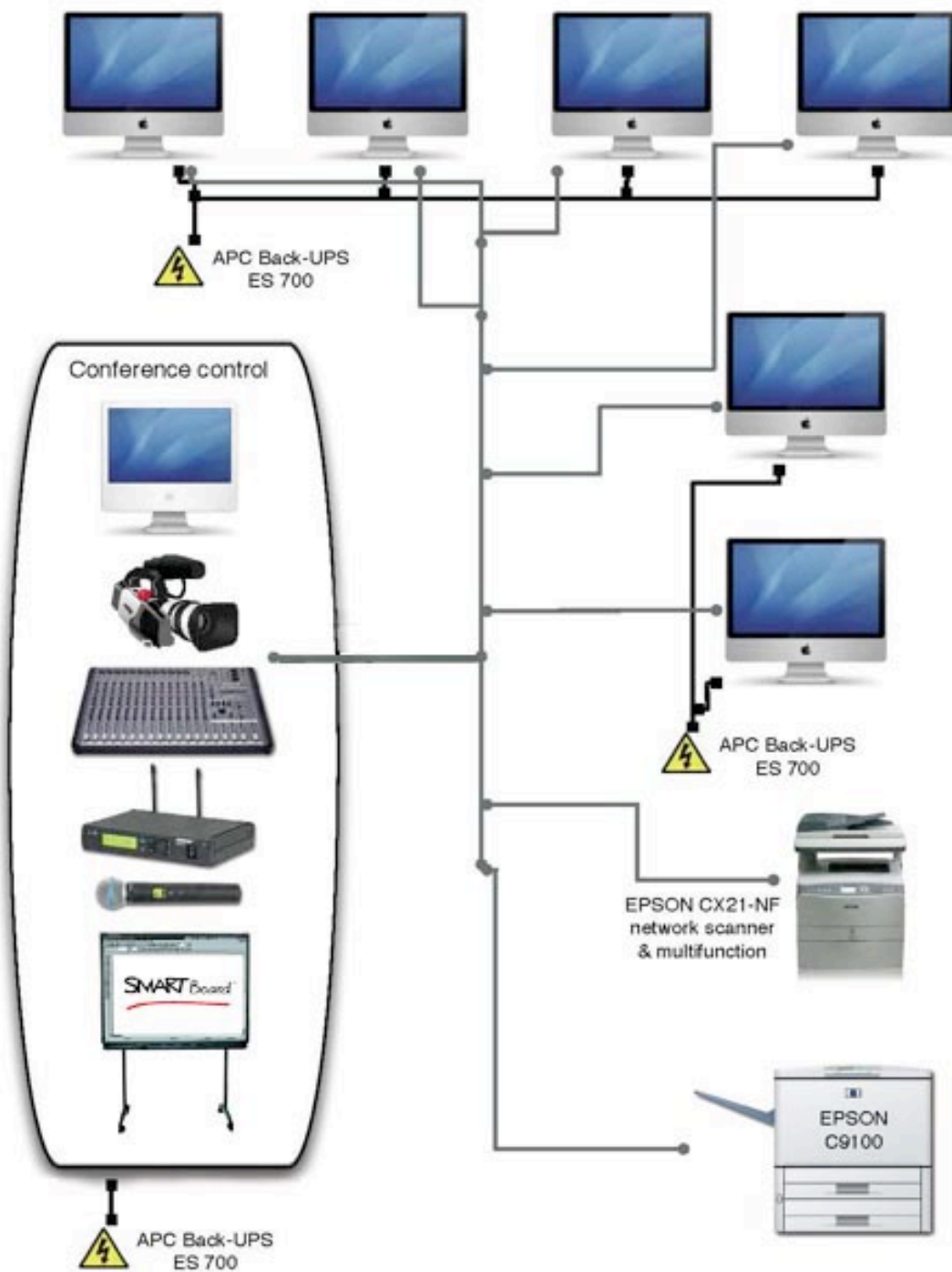

EUROPEAN/INTERNATIONAL JOINT PhD LAB DIRECTOR



Annamaria Silvana de Rosa, Ph.D. in Psychology is **Full Professor** of Social Representations and Communication: with integrated experimental laboratory on New Media at the Faculty of Medicine and Psychology - University of Rome "Sapienza", Italy; **Rector's Delegate for EUA-CDE Council of Doctoral Education**, as leader for the **Internationalisation of doctoral education**. She has a position of institution-wide responsibility role for international doctoral education, as **Director of Sapienza Coordination Program for International Doctorates** (<http://www.uniroma1.it/didattica/offerta-formativa/dottorati/sapienza-co-ordination-program-joint-european/international>) since 2009 and as **Rector Delegate in the EUA-CDE Council of Doctoral Education**, since its inception, and member of the Board of Directors of the International Relations .

Professor de Rosa has been a motor for reform in doctoral research training and one of the best-informed and most passionate educators encouraging innovation in doctoral education in Europe. She has made important scientific and institutional contributions to the internationalisation of the doctorate and has participated extensively in discussions in European and international forum, where she is widely considered an expert on the reform of European doctoral programmes and other research training issues. Her active contribution to the European University Association is well known, especially since her participation as **leader of the EUA Doctoral Project "Network of networks"**.

She created and is the Programme Director of the first international joint doctorate, awarding a mutually recognized "European doctoral diploma" under the joint signatures of the rectors of the network universities (<http://www.euophd.eu>): the **European/International Joint PhD in Social Representations and Communication**, that since 1993 has been approved by the European Commission (DG-Education and Culture and DG - Research) as well as by the Ministries for Scientific Research and Higher Education of Italy, France, the Czech Republic and Romania and sponsored by the French social sciences Foundation Maison des Sciences de l'Homme (FMSH). Fully operational since 1996, the original network of 13 European universities has since grown to 28 universities, research institutes and SMEs in 18 countries around the world. 17 universities in 10 European countries (AT, CZ, FR, IT, PT, RO, SK, ES, CH, UK) and 7 universities from North America, Latin America and China, 1 national research institute (IFSTTAR) in France; 1 social sciences foundation (FMSH) and 3 enterprises partners in Netherland, Italy and Sweden. Among them 16 associated partners have been chosen and have recently adhered to the PEOPLE-ITN **SoReComJoint-IDP** project (13 universities, 2 private companies, 1 national research institute IFSTTAR with intensive and extensive cooperation with the private sector) in 8 European countries (Austria, Czech Republic, France, Italy, Romania, Spain, Sweden, Switzerland) and in 6 extra-European countries (Argentina, Brazil, Canada, China, Mexico, United States). Within the FP7 PEOPLE-ITN-2013 programme, the **SoReComJoint-IDP** project has been selected as being the best among the 1147 submitted proposals, obtaining mark of 98,80/100 (threshold: 70/100).

The European/International Joint PhD in Social Representations and Communication programme has been identified as an example of '**best practices**' in higher education by the European Commission Directorate for Education and Culture, by the Italian and French Ministry for Scientific Research and Higher Education. In 2010 an award for the **best paper** has been released by the Joiman EC Project – Task Force 4 to the Scientific Coordinator of the European/International Joint PhD in Social Representations and Communication for the following paper: de Rosa, A.S. (2010). *The Joint European/International Doctorate in Social Representations and Communication: an experience anticipating the Bologna process*.

Within Sapienza University, she occupies positions of responsibility as **member since 1992 of the Core Committee on International Relations (CURI)**, **creator and Director of the Sapienza Co-ordination Program for Joint International/European Doctorates** and, since its creation in 2000, of the **European/International Joint PhD in Social Representations and Communication Research Centre and Multimedia Lab**, one of the most advanced High Tech labs at Sapienza University. Since 1992, she has directed, with excellent management skills, a long series of successful projects approved by the European Commission. These **EC-contracts** include: the Erasmus-Socrates programmes for Advanced Curriculum Development and Intensive Programmes approved by DG-Education and Culture (1993-2012), Training Mobility Researchers, the High Level Conference programmes, MSCA FP7 PEOPLE-ITN-2013. Since 1995 she has organized a successful series of 23 [International Summer Schools](#) and 34 [International Lab Meetings](#), which were attended by 1552 research trainees from 59 countries and 415 guest speakers from 28 countries have participated to the 57 international scientific organised until the Summer School 2017.

Since 2000, she has been **Coordinator of the Marie Curie Multi-partner Training Site on Social Representations and Communication** approved by DG-Research. From 2004 to 2008 she was the scientist in charge of a series of 12 **European/International Joint PhD International Lab Meetings** funded under the *Marie Curie Series of Scientific Events* and is currently directing a new series of three scientific events per year (Winter, Spring and Summer Sessions), which will

continue to integrate face-to-face meetings with on-line training courses for European/International Joint PhD research trainees and young doctoral and post-doctoral researchers from all over the world.

Since 2004 she has been **Coordinator of the EU-approved *SoReCom Thematic Network of excellence***. She has also been the coordinator of two internationalization programmes sponsored by the Italian Ministry of Higher Education and since 2002 has served as Coordinator of the Vinci Programme funded by the French and Italian Ministries of Higher Education. In 2004 the European University Association (EUA) designated her the **main coordinator of the “Network of Networks”** project, part of their Europe wide study on the status and future of doctoral education. As **Rector’s Delegate for EUA-CDE Council of Doctoral Education**, she regularly and actively attends all EUA international workshops and those organized on doctoral education by other international associations like EAHEP and UNICA. She has also been invited to organize the EUA-CDE Working Group on the Internationalisation of Doctorate and International Joint Doctorate (March 2010). For many years, she has been the Erasmus Institutional Coordinator as the delegate of the Rector of the University of Rome Sapienza for the Socrates programme, the European University Association, the UNICA network and a member of the Board of Directors of EuroPACE, a trans-European network of universities specialized in open distance education and training.

Prof. de Rosa has been invited as an **international expert to evaluate research programmes** of the Canadian Fonds pour la Formation de Chercheurs et l’Aide à la Recherche (FCAR) in Québec since 1995, by the Italian Ministry of Scientific Research (MIUR) since 1998, by the Canadian Social Sciences and Humanities Research Council (CRSH) since 2002, by the European Science Foundation (ESF) since, the Belgian Federal Science Policy Office since 2008, by the Qatar National Research Fund (QNRF) since 2008.

Prof. de Rosa is the author of **more than 600 scientific contributions**, including **more than 230 publications** in the supra-disciplinary field of Social Sciences inspired by the theory of Social Representations and active participation as invited keynote speaker or symposium organiser in **more than 370 conferences** in international and national conferences in Social Psychology and other Social Sciences and in the fields of Innovative Doctoral Education and of Digital Libraries and ICT applied to Higher Education.

In 2014 Prof. de Rosa has been selected as Sapienza University representative and expert to intervene during the parallel workshop on “*Internationalisation in doctoral training: collaborative projects, co-tutelle, joint doctorates*”, within the conference ‘*International, Intersectoral, and Interdisciplinary: the triple “i” approach to doctoral training*’ (Padua, 20 -21 November 2014), organised by the Italian Ministry of Education, Universities and Research, in collaboration with the University of Padua and the University of Camerino, and with the expert advice of the EUA-Council for Doctoral Education. under the auspices of the Italian Presidency of the Council of the European Union.

She has also contributed with **57 key lectures in the multiyear series of the International Summer Schools and International Lab Meetings** she has organised since 1995 for the European/International Joint PhD in Social Representations and Communication.

In the field of social representations she has developed the “**modelling paradigmatic approach**”, based on the integration/differentiation of multi-theoretical constructs and multi-methodological research designs. It represents the unifying epistemological inspiration of her research programs, including a **variety of thematic topic**, such as (among others): madness and mental illness; environment and tourism; national, supra-national and place identity; city-branding of the European Capitals via traditional and new media; advertising and communication; social memory and emotional impact of traumatic events; interpersonal perception and family relationships; social representations of current, future and ideal family; temporal perspective, social representations and metaphors of the stock market in traditional and new media, investors and financial advisors from various European countries and China; social representations of psychoanalysis in the era of Facebook; polemical representations about environmental/economic ideological conflicts: the case of TAV / No-TAV movement on the streets and in the social networks; 99% versus 1% polemical representations about financial-economic issues: putting finance “under accusation” by Occupy Wall Street from the US to Europe and China; more recently on social representations of immigrants/migrants/refugees, social memory and multi-dimensional identities and integration processes in the host/destination country and communicative dimensions within face-to-face and virtual reality of socio-interpersonal networks from the origin and host country.

One of her recent books is entitled «*Social Representations in the Social Arena*» (Routledge, 2013).

She is also the creator of the ***So.Re.Com. “A.S. de Rosa” @-library***, a multipurpose digital environment of interrelated relational databases conceived in the logic of the semantic web, including multiple web interfaces aimed to integrate *documentation services*, with *networking* and *research training*. This @-library supports access to multiple repositories and web-tools, designed by A.S. de Rosa and implemented on the EuroPhD website, currently evolving into a new advanced platform for knowledge discovery, sharing and analysis and to support researchers networking and collaboration. By implementing additional capabilities such as enriching publications with additional bibliographic metadata, provide bibliometric indicators, add authors and institutions profiles, researchers networking tools, etc., the platform will not only allow comprehensive and accurate bibliographic searches, but will also enable sophisticated analyses aimed at identifying relevant dynamics within the researchers community, such as collaboration patterns, semantic clusters, research trends, scientific impact and other emerging properties that can be captured with a bottom-up analytical approach. Furthermore, the integration of social networking tools aimed at scholars will enhance collaboration among scholars, thus helping promoting both the development of the discipline and the careers of the members of this community (de Rosa, 2014a, 2014b, 2015a, 2015b, 2016, 2017).

In 2014, prof. de Rosa has established a strong collaboration with Elsevier for joint research activity on the impact of the bibliometric culture and its practice in the scientific community she leads and for the exponential technical development of the ***So.Re.Com. “A.S. de Rosa” @-library***.
