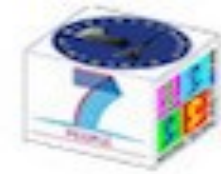

# Presenting the European/International Joint Ph.D in SR & C



- ▶ The European/International Ph.D on Social Representations and Communication is an EU- approved training structure , designed in 1993 and operational since 1996, **that provides advanced research training for early stage researchers in a cross-disciplinar paradigmatic field based on the SR theory and Communication studies** (de Rosa, 2004, 2007; 2009a, 2009b, 2010).
- ▶ It is grounded on Social Psychology however it privileges the contact with sociology, anthropology, communication studies, socio- economic and political science, education, environmental studies and other thematic fields related with social issues

# Presenting the European/International Joint Ph.D in SR & C



- ▶ The main goal is to **prepare researchers for traditional academic careers as well as providing the private and public sectors with researchers expert in the Social representations field** (de Rosa, 2009)
- ▶ The program meets the strong demand for **interactive networking and innovative research training in social sciences**, providing the opportunity for the trainees to **work in different cultural and linguistic settings while offering a didactic structure of a wide range of research methodologies and complementary skills** (de Rosa, 2009)
- ▶ **Selected by DG Education and Culture as an example of "best practices" for dissemination in higher education**

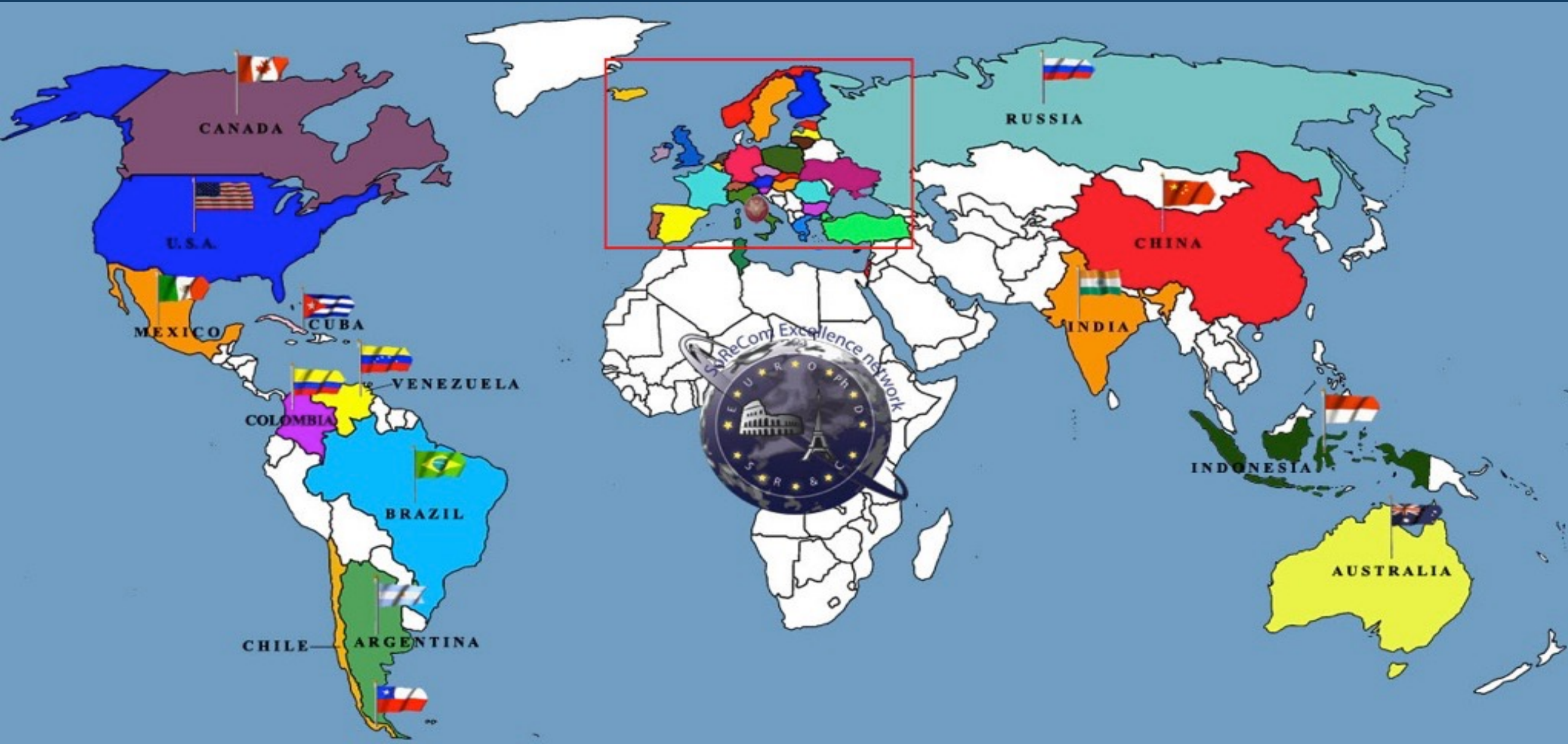

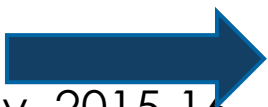

## Presenting *So.Re.Com Joint-IDP -The project*

- ▶ Research program led by Prof A.S. de Rosa built on the experience of an on going project led by her over two decades is aimed at **taking stock stock of the scientific field developed in more than 50 years** by conducting an **empirical meta-theoretical analysis of the literature on Social Representations**, using the specific web tools designed by her, **full bibliographic repository, meta-analysis repository, specialised SoReCom “A.S. de Rosa” @-Library and search engine connected with all the above mentioned repertoires**, including a very rich documentation(de Rosa 2009a, 2009b, 2010)

Through the meta theoretical analysis of the whole body of literature, we aim to map:

- ▶ **the development of different paradigms**
- ▶ **the related research methods**

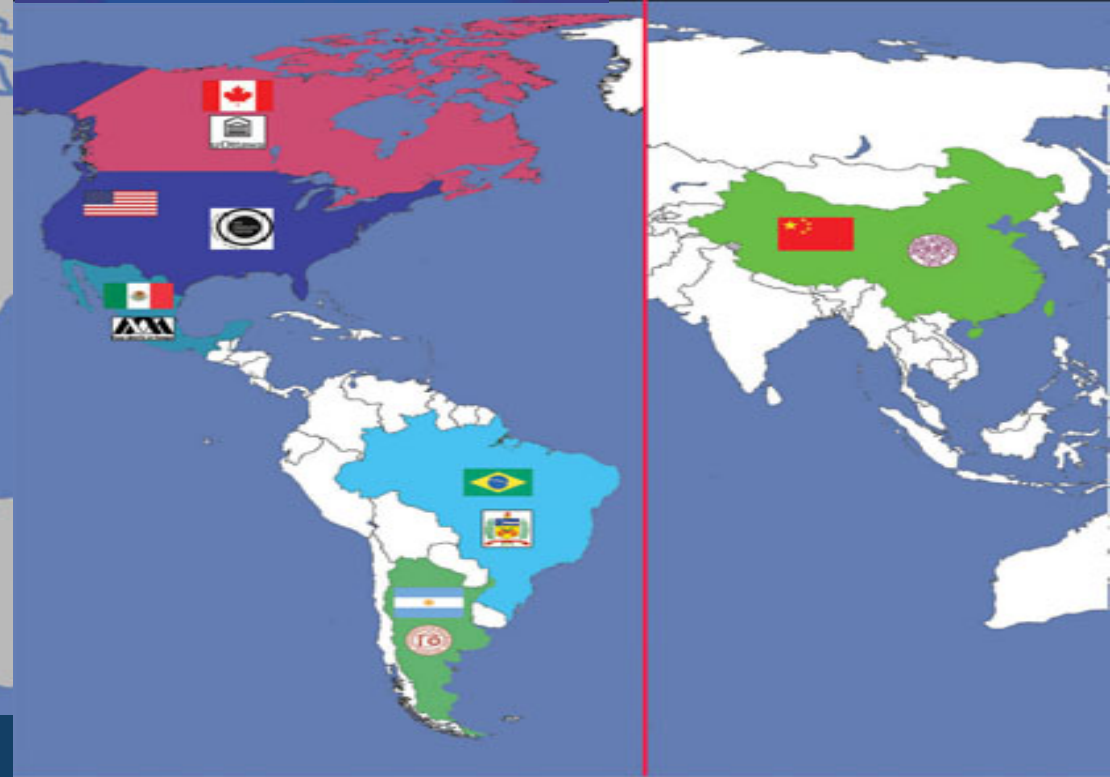
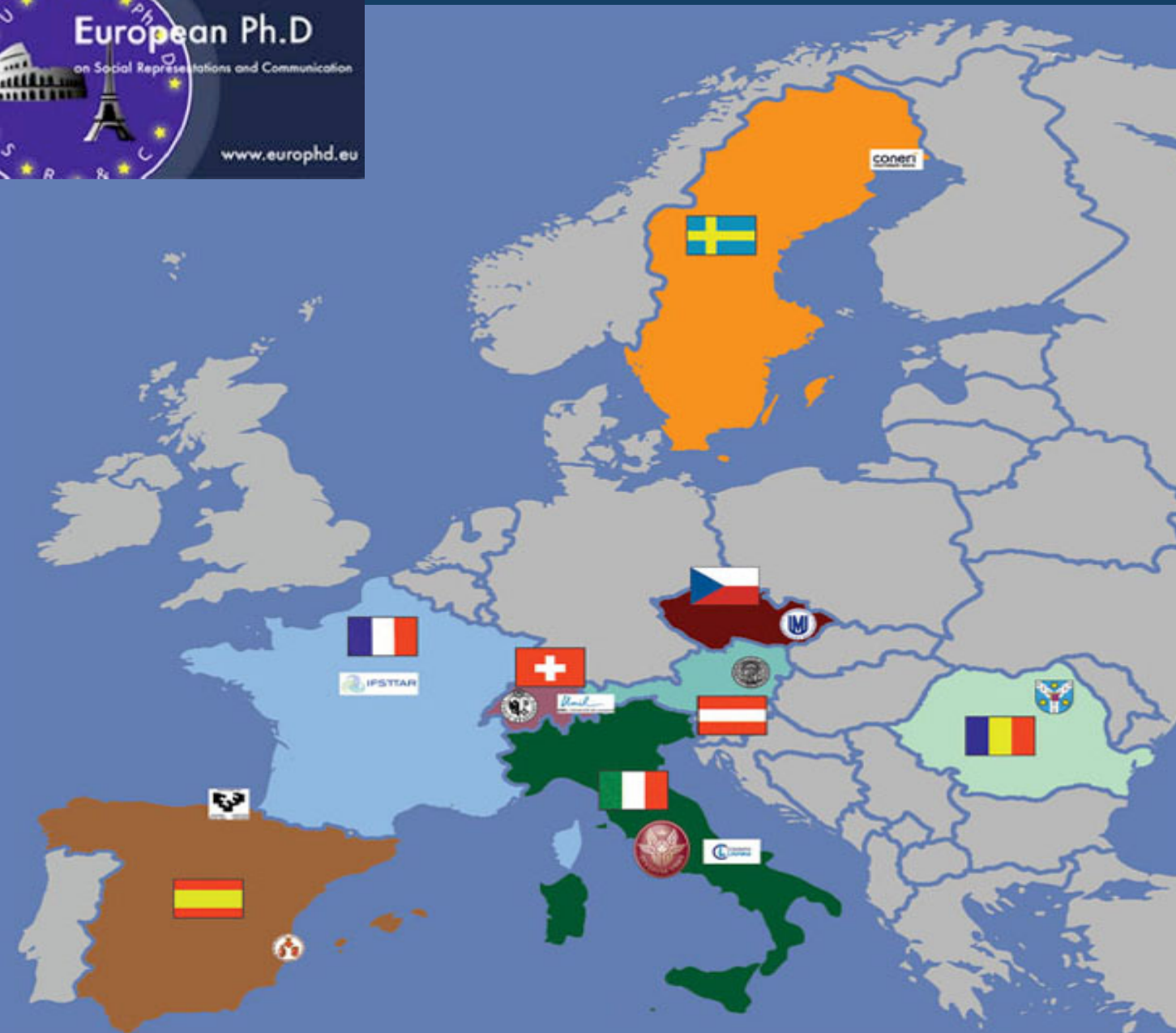
## Presenting *So.Re.Com Joint-IDP- Methods*



- ▶ The meta analyzed inventory of the theoretical and empirical literature of the field is done according to **an online grid** designed by de Rosa (de Rosa, 1994) that **integrates two levels**(de Rosa, 2013 a, b):

- 1) **Descriptive**, in line with a traditional bibliometrical approach
- 2) **Meta theoretical** comprising a multiple perspective analysis of **five main areas**:
  - a) general and specific theoretical references to SR constructs
  - b) theoretical references to other constructs and theories
  - c) Methodological profile
  - d) Paradigmatic coherence between the theoretical assumptions
  - e) Methodological research design

# European/International Joint Ph.D in SR & C and So.Re.Com Joint Idp Tasks and methodology



## 1) **detect and retrieve publications not yet inserted in the specialized SoReCom “A.S. de Rosa” @-Library,**

*a multipurpose digital environment of interrelated relational databases conceived in the logic of the semantic web, including multiple web interfaces aimed to integrate documentation services, with networking and research training. This @-library supports access to multiple repositories and web-tools. By implementing additional capabilities such as enriching publications with additional bibliographic metadata, bibliometric indicators, authors and institutions profiles, researchers networking tools, etc., this platform will not only allow comprehensive and accurate bibliographic searches, but will also enable sophisticated analyses aimed at identifying relevant dynamics within the researchers community, such as collaboration patterns, semantic clusters, research trends, scientific impact and other emerging properties that can be captured with a bottom-up analytical approach (de Rosa, 2014a, 2014b)*

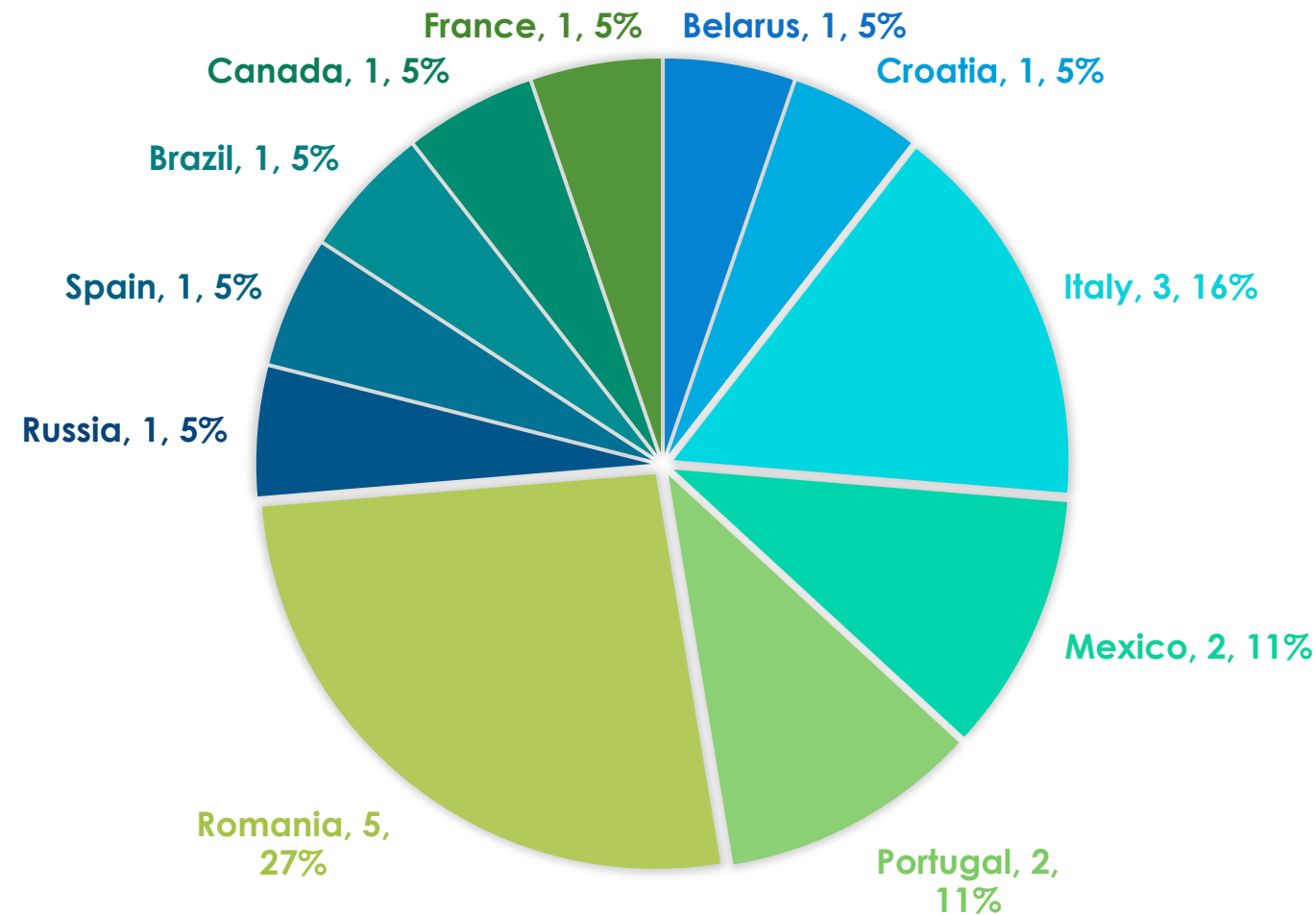
# European/International Joint Ph.D in SR & C and So.Re.Com Joint Idp

## Tasks and methodology



- ▶ **Meta-analyse the whole body of the literature on Social Representations** produced according to the “specific focus on the individual research project” over the world and not only in the geo-cultural context/continent of the host institution for mobility stage ( de Rosa, 2013a, 2013b)
- ▶ **to fill the new information and upload the related PDF files into the specialized SoReCom “A.S. de Rosa” @-Library;**
- ▶ **to carry out statistical analyses on the complete meta-analysed body (extracted from the SoReCom “A.S. de Rosa” @-Library inventories after the integration** of the new information);
- ▶ **to produce video-interviews** – according to an outline designed by the project leader - with the key scientists who contribute to the development of the “specific focus on the individual research project” to Social Representations;
- ▶ **to fully describe, visualize and comment the results obtained in intermediate reports and in the PhD thesis** (in the double format of detailed report in English and a short article)

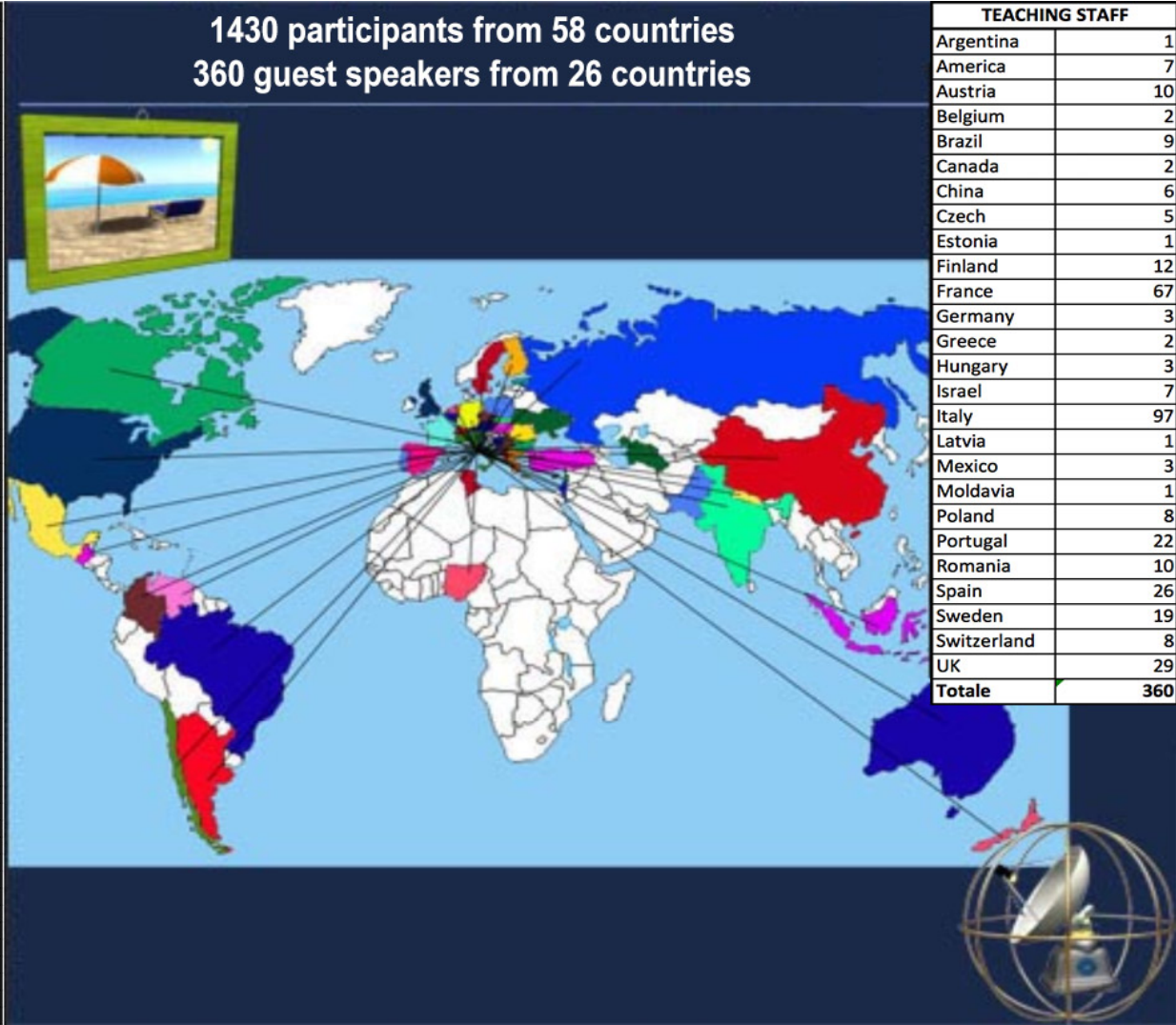

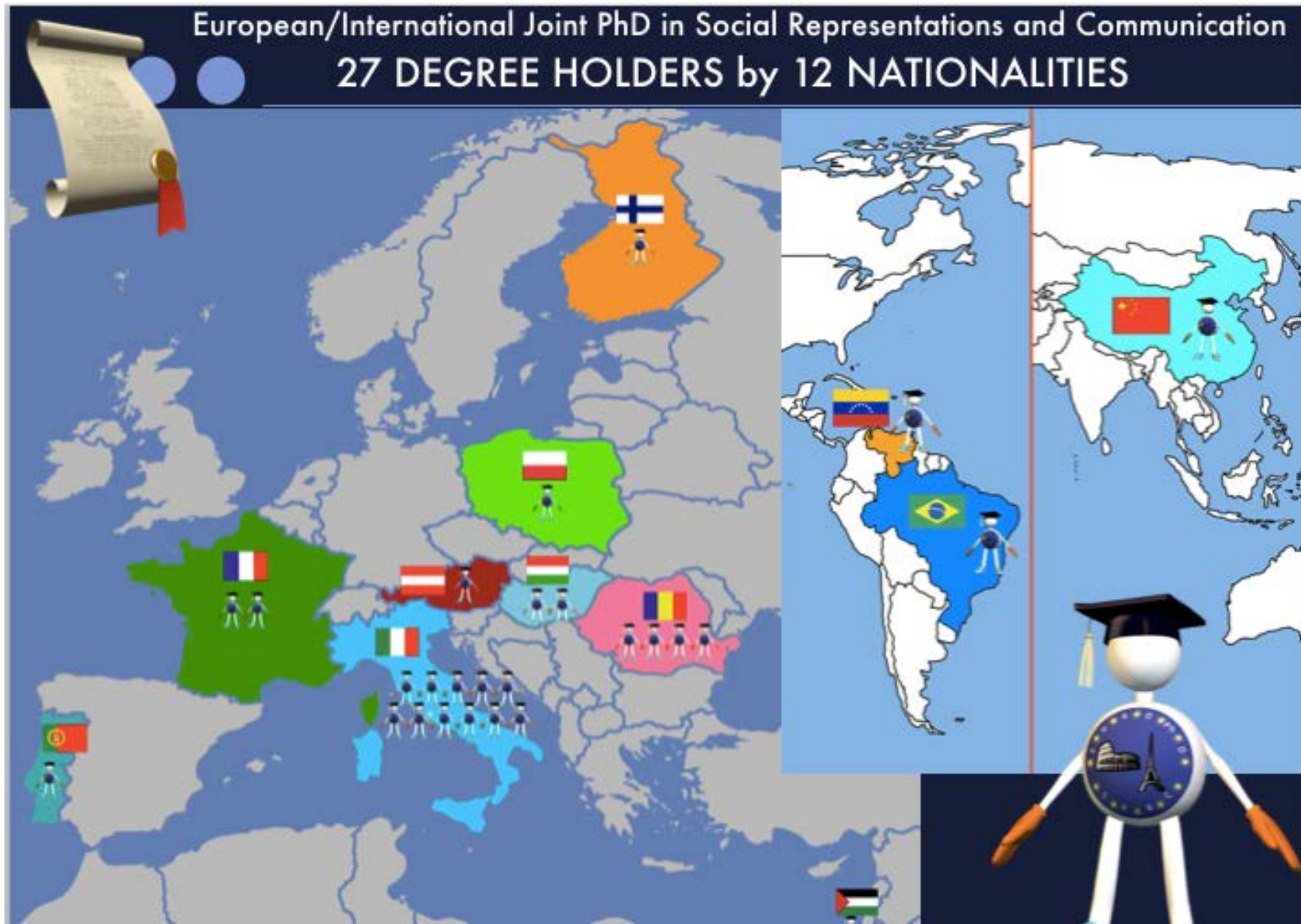
