# **Recruitment Board Selection Report**

## 1. Methods and criteria of selection

As indicated in Annex I of the grant agreement, the selection is a multistep process based on:

- a) the comparative analysis of the application dossier by the members of the Core Executive Committee
- b) an interview with the Recruitment Board composed of the SoReCom Joint IDP Scientific co-ordinator -
- sole responsible for the final ESR's admission of applicants and other members of the Scientific Supervisory Board (30 points)

For both steps the evaluation has been made on the basis of the scientific quality of applications, the compatibility of the applicants background and required language skills with the research topics offered in the vacancy.

To be admitted the candidate must achieve for each step a score of at least 20/30 and an overall score of at least 40/60.

Consequently to the evaluation the Recruitment Board prepares the classification of the candidates in a descending order of the overall score given to each candidate. The first thirteen candidates will be awarded a SoReCom Joint-IDP fellowship. In case of withdrawal of one of the selected candidates the fellowship will be assigned to the first of the non-selected candidates that has obtained an overall score of at least 40/60.
