10th International Conference on Social Representations “Representations, Knowledge Transmission and Social Transformations”

In line with the tradition established since 1992 in Ravello (Italy) and continued in Rio de Janeiro (Brazil) in 1994, Aix-en-Provence (France) in 1996, Mexico City (Mexico) in 1998, Montréal (Canada) in 2000, Stirling (GB) in 2002, Guadalajara (Mexico) in 2004, Rome (Italy) in 2006 and Bali (Indonesia) in 2008, Tunisia has hosted the 10th International Conference on Social Representations from the **5-8 July 2010** in **Gammarth**.

Jean Claude Abric was the honorary President of the 10th ICSR while the organiser was Dorra Ben Alaya, who has welcomed all the participants with her charming personality and efficacy in dealing with any kind of issue.

This conference, dedicated to the theme: « **Representations, Knowledge Transmission and Social Transformations** », allowed the members of the world-wide scientific community inspired by the theory founded by Serge Moscovici in 1961, to present and discuss their last research works, as well as the theoretical and methodological reflexions aiming at the development of this theory.

The event has been a great success, and has seen the participation of 270 among professors, researchers and PhD trainees from 32 countries: Algeria, Argentina, Austria, Brazil, Canada, China, Czech Republic, Denmark, Finland, France, Great Britain, Greece, Indonesia, Israel, Italy, Ivory Coast, Japan, Kenya, Malta, Mauritania, Mexico, Porto Rico, Portugal, Romania, South Korea, Spain, Sweden, Switzerland, Taiwan, Tunisia, USA, Venezuela.




FP7-PEOPLE-ITN project

Our “FP7-PEOPLE-2010-ITN” - SoReComTheNet EuPhD project proposal, submitted last December to the European Commission, has received an excellent evaluation and has passed all evaluation thresholds, obtaining a mark of 82,40 (the threshold was 70,00).

Due to the limited budget available, the Research Executive Agency must also take account of the strategic objectives of the programme, as well as the overall balance of the proposals and new networks to be funded. Therefore, only 7 out of the 863 presented proposals have been funded in the field of Social Sciences.

Despite the many strengths of the proposal acknowledged in the evaluation by the EC (good training capacities, incorporation of non-EU partners, appropriate management policy, efficient networking, exploitation of synergies and complementarities among partners, very good scientific quality of the research programme with an appropriate methodology, very good training on supra-disciplinary fields, international mobility, use of IT tools, etc.), the project has unfortunately not been included among the seven projects funded in the field of social sciences.
