## European/International Joint PhD in S.R. & C. Institutional News

## The European/International Joint PhD in S.R. & C. regains its autonomy

The European/International Joint PhD in Social Representations and Communication has regained its full autonomy and is no longer integrated as a curriculum of the doctorate in *Social Psychology, Developmental Psychology and Educational Research*.

The European/Joint International PhD has fulfilled all the following criteria set by the Italian Ministry for University and Research for the accreditation of doctoral programmes (22 May 2013):

- 1. Approval by the Sapienza Doctoral Committee (29 April 2013)
- 2. Positive evaluation by the Sapienza University Quality Evaluation Board (4 June 2013)
- 3. Approval by the Sapienza Academic Senate (13 June 2013)
- 4. The European/International Joint PhD is a consortium of universities (among which at least one Italian university) that delivers a joint diploma
- 5. The doctorate's Scientific and Teaching Board scientific production for the last five years has been positively evaluated
- 6. Thanks to the recently approved PEOPLE-INT-2013 project the European/International Joint PhD has more than the minimum required 4 fellowships that must be made available yearly
- 7. Availability of a fully equipped multimedia laboratory
- 8. Availability of an adequate physical and virtual library

## European/International Joint PhD announcement for a.y. 2013-2014



The European/International Joint PhD in S.R. & C. informs that the announcement for a.y. 2013-2014 is available on its website as well as on EURAXESS (http://ec.europa.eu/euraxess/index.cfm/jobs/fgDetails/49340). The European/International Joint PhD in S.R. & C. represents a progressive educational curriculum for training early stage researchers through research in a scientific and paradigmatic field inspired by the Social Representations Theory and Communication studies. Although having a special focus on Social Psychology and media studies, it draws in a wide scientific community across continents and many disciplines dealing with social sciences and it has created a Thematic Network of Excellence approved by the European Commission (http://www.europhd.eu/SoReComTHEmaticNETwork)

The European PhD, coordinated by Sapienza University of Rome, includes 17 universities in 9 European countries (AT, CH, CZ, ES, FR, IT, PT, RO, UK), 7 universities in North America (Canada, USA), Latin America (Argentine, Brazil, Mexico) and Asia (China), 1 French National Research Institute, 1 social sciences foundation (Maison des Sciences de l'Homme) and 3 SMEs in 3 EU countries (IE, IT, SE). In its role as co-ordinator diplomas are issued by Sapienza University with the signature of the rectors/presidents of the six universities which jointly confer the degree: University of Rome Sapienza (ITALY), University of Aix-en-Provence, the University of Montpellier III "Paul Valéry" and University "Lumière" Lyon 2 (FRANCE), University A I. Cuza of lasi (ROMANIA), and Masaryk University, Brno (CZECH REPUBLIC). The Research Trainees have then access to a large number of academic infrastructures and are followed by 1 main tutor and 2 international cotutors in at least 3 of the above mentioned countries. Moreover, at the European PhD Multimedia Lab and Research Centre in Rome they will participate in innovative scientific and didactic activities like the International Lab Meetings and Summer Schools using technologically advanced resources.

## Successful Negotiation of the PEOPLE-ITN SoReComJointIDP contract

It is with great pleasure that we announce that the project "The European Joint Doctorate on Social Representations and Communication: an innovative doctoral program in a networked international research training environment" submitted on the 21st November 2012 by the European/International Joint PhD Programme Director within the FP7-PEOPLE-ITN programme has been successful (Grant Agreement PITN-GA-2013-607279 - SoreComJointIDP). The proposal obtained an overall evaluation of 98,80/100, the best of all the 1175 submitted proposals within the 2013 call.

The SoReComJointIDP includes a training network of 16 associated partners (13 universities, 2 private companies, 1 public research centres with intensive and extensive cooperation with the private sector) in 8 European countries (Austria, Czech Republic, France, Italy, Romania, Spain, Sweden, Switzerland) and in 6 extra-European countries (Argentina, Brazil, Canada, China, Mexico, United States). Its goal is to provide doctoral training in Social Representations and Communication, a supra-disciplinary research area of the social sciences that studies the social construction of everyday knowledge in social spheres and media, disseminating European excellence beyond the EU boundaries and attracting the best Early-stage researchers (ESR) from abroad.

The project foresees the recruitment of 13 ESR fully funded on project funds. A call for vacancy will be issued defining a priority list of projects guided by the main goal of evaluating the impact of the scientific production driven by the Social Representations theory in the social arena faced with social demand. The aim is to take stock of the scientific field developed in more than 50 years by conducting an empirical metatheoretical analysis of the literature on Social Representations, mapping the development of different paradigms, the related research methods, the thematic areas and their impact on the various applied fields within the multi-generational community of scientists and across different geo-cultural contexts. This unified research project framework will be articulated into 13 precise objectives concerning the specific research lines to be developed by each recruited ESR, matching their own interests and area of prior expertise.

A pre-announcement containing all the necessary information such eligibility criteria for potential candidates, deadlines, required documentation, amount of the fellowship, topic of the research projects, etc. is published online at: http://www.europhd.eu/html/doc/pre-annoucement\_people\_idp\_2013.pdf

The project will start on 1 October 2013 and will last 48 months. A kick-off meeting with all the partners will be held on Friday 4 October 2013 to officially launch the project.

To resume, the contract will ensure the European/International PhD's sustainability for the next 4 years through:

- guaranteeing the series of 10 training events for the next 4 years (winter, spring and summer sessions). In addition to the 13 People ESR fellows and other doctoral students enrolled into the European/International Joint PhD, researchers external to the network may also be potential candidates to participate in the Summer Schools or Spring Sessions of the International Lab Meetings and, if selected, they will be admitted without paying the event registration fees;
- the 13 fellowships that will be awarded to eligible candidates for the benefit of the whole network (that, as stated in the guidelines at page 15, paragraph 1.3.5., cannot be from Sapienza University, although they will be hosted at Sapienza, but can instead be promoted by all the associated partners, in addition to independent candidates from any part of the world expect from Italy);
- covering the expenses for the network's programme management, which include the dedicated staff, the organisation and participation to coordination meeting, the dedicated infrastructures and website, administration, etc

## 21st European/International Joint Ph.D. in S.R. & C. Winter Lab Meeting 14th-15th JANUARY 2013, Rome (Italy)



The 21st Edition of the International Lab Meeting – Winter Session 2013 has been held on the 14th - 15th of January 2013 at the European/International Joint PhD in S.R. & C. Research Centre & Multimedia Lab (Rome - Italy). This *compulsory intensive training* event was split in two specific sessions:

## EASP Small Group Meeting: Developing Diversity in EASP University of Lausanne, Switzerland, June 12 – 14, 2013

The EASP SGM on "Developing Diversity in EASP", organised by Steve Reicher (St. Andrews University), Ewa Drozda-Senkowska (Paris Descartes), Bernd Simon (University of Kiel), Christian Staerklé (University of Lausanne) and Chiara Volpato (Milan Bicocca) was held at the University of Lausanne (June 12 – 14, 2013).

From its inception, EASP was committed to developing a social psychology which embraces all of Europe, which includes all sections of society and which is open to multiple intellectual traditions. In many ways, the Association has made remarkable strides forward in all of these respects, but equally, it is undeniable that we are still far from perfect, for example in terms of geographical diversity, gender equality and scientific recognition of different intellectual and methodological traditions. Moreover, it is arguable that the current economic crisis may have detrimental effects on our discipline. Funding cuts may affect the periphery more than affluent centres and increased competition privilege traditionally valued forms of research.

This small group meeting addressed these issues. It had three aims: (1) to clarify the current state of affairs as concerns diversity in EASP; (2) to analyse the source of the problems; (3) to develop concrete plans for changes in the Association. The meeting was structured in workshop format in order to maximize discussion and ensure that concrete outputs emerge from these debates. For each workshop participants were asked to prepare position statements as a basis for discussion.

## VI EUA-CDE Annual Meeting: From Student to Researcher – are we on the right track? Hosted by the University of Warsaw, Poland - 18-19 June 2013

The trend is clear: structured doctoral education is becoming the norm for doctoral education. Universities have introduced doctoral schools and taught courses; they are monitoring the progress of doctoral candidates and quality of supervision and research in doctoral programmes. At the same time, new legislation is being drafted or implemented across the continent. There are new requirements for the institutional management of doctoral education, and quality assurance agencies and research assessments are taking a more specific interest in the area. This is a good time to ask: are we keeping focus on the goal of doctoral education, to make students into researchers? Are we on the right track? The Sixth Annual Meeting of the EUA Council for Doctoral Education held last June in Warsaw is the largest gathering of all stakeholders in the field of doctoral education in Europe. It provides ample opportunities for open discussions of challenges and opportunities between colleagues from all over Europe. There were learning opportunities for newcomers to the field of doctoral education as well as a master class for the 'veterans' of the field. The conference aimed specifically at opening discussions between different stakeholders such as university leaders, researchers, political decision-makers, funding organisations, quality assurance agencies and all others interested in the development of doctoral education.




The forthcoming publication of Serge Moscovici's book "Le scandale de la pensée sociale", a series of Moscovici unpublished works that have been gathered and introduced by Nikos Kalampalikis, will be available in September 2013 on E.H.E.S.S. website (ISBN 978-2-7132-2375-4. Publisher: E.H.E.S.S. http://www.editions.ehess.fr/ouvrages/ouvrage/le-scandale-de-lapensee-sociale/)

In 1961 Serge Moscovici elaborates the Theory of Social Representations. This collection of unpublished works (in French) tells of the theory's genesis, questions its link with social psychology as well as its current pertinence.

How to understand the economic crisis? How to face ecological challenges? What is a healthy nutrition? Why bioethics? To explain what is happening in our complex world, we create metaphors, images, symbols and words that form social representations. In 1961, Serge Moscovici proposes a theory of those representations. This book gathers, for the first time, some unpublished works (an articulated and argued answer to a critique article, a comment on a text, a conference, a discussion, etc.). Those works are a precious tool to understand the path of his theory in the history of ideas, to question its link with social psychology, but also its pertinence to understand our current societies.

### **Editorial News**



We are proud to announce that one of European/International Joint PhD holder, Grigore Havarneanu, has published his first book on the subject of his PhD thesis "*Psihologia Transporturilor*" (ISBN 978-973-46-3238-1. Publisher: Polirom). The book is introduced by our deeply regretted friend, Adrian Neculau.

This book aims to apply cognitive and social psychology for understanding and explaining human behavior in traffic. The main objective is to make the reader familiar with the main theories in the field and the most important results of recently published studies. In addition to the theoretical orientation, the work has been directed towards practical possibilities of psychological intervention to change aberrant behaviors and improve driving performance. In this direction, the emphasis is on other types of intervention than skill assessment. The concepts, models and theories in the literature are discussed in the Romanian traffic context, pointing out the weak points of the road safety in this country and seeking to broaden the range of activities of private traffic psychologists.

The book covers the fundamental topics in the field, but also emphasizes on the approaches that are less common. Based on a comprehensive analysis of the theoretical and empirical literature, the book provides a reference framework for

a modern psychology of road user behavior, which includes driving behavior but is not limited to it.

It can also persuade students to get involved in this area of applied psychology and conduct more research on human behavior in the traffic environment. "This book belongs to a representative of a new generation of professionals, generation that had access to sources of information and new practices, familiar with recent research in the field, and taking what is best from the internships in major research centers and laboratories in Europe" (Adrian Neculau).
