# The So.Re.Com. Joint-IDP Early-Stage Researchers Activities – June 2015

In the first part of the month of June 2015, the Early Stage Researchers have continued their task of the **meta-theoretical analysis**, based on the Excel grids organized by research focus and individual separate folders with PDFs for each research focus. As in the last month, some of the trainees have to carefully check the data that is going to be imported to the virtual library. In fact, more trainees have become involved in this task due to the time pressure.

In the second part of the month of June 2016, the Early Stage Researchers have been invited to plan a proposal for their individual lists of publications to be meta-analyzed during the secondment period. Such lists have been discussed with Prof. de Rosa, Prof. Leone and Dr Dryjanska during **individual meetings** that took place on June 15, 2015.

On June 25, 2015 some of the trainees have been introduced to the task of cooperation in supervision of master students who are contributing to the development of the SoReCom "A.S. de Rosa" @- Library by searching for new references during their extra-EU Sapienza scholarships in Argentina, Brazil and Canada. The joint meeting took place, introducing the Early Stage Researcher to the students and outlining the administrative and scientific aspects of cooperation.

On June 26, 2015, **SoReCom Joint-IDP Lab Seminar** "Food for mind and Methodological Training" consisted of the presentation entitled "Popular practices and social representations of health in the ribeirinhas communities" by Luana Michele da Silva Vilas Boas from the University of the State of Rio de Janeiro, with the participation of the early stage researchers, Prof. Paola Passafaro, PhD trainee and the Project Leader.

On June 30, 2015 a brief meeting was held to illustrate the contents of the "Mid-Term Assessment Questionnaire" designed to give the REA-Research Executive Agency feedback on the training/research activities of the fellows. Before completing it (deadline Wednesday 1 July), and for the trainees to become aware of administrative details and some peculiarities given the fact that the questionnaire has not been designed specifically for a ITN-Innovative Doctoral Program (IDP), like the SoReCom Joint-IDP, the fellows were kindly asked to read at the link:

# The So.Re.Com. Joint-IDP Mid-Term Assessment Questionnaire

On the 30<sup>th</sup> June, 2015, the early stage researchers had a meeting with the **Project Manager Dr Robert Barakat** and the **Project Leader Prof. Annamaria Silvana de Rosa**, also attended by Prof. Elena Bocci and Dr Laura Dryjanska, dedicated to the compilation of the online **MSCA Questionnaire** required by the European Commission, in accordance with the Marie Curie ITN Guidelines, at least 2 weeks before the Mid-Term Review meeting each recruited researcher employed in the frame of the project must complete and submit the online "**Mid-Term Assessment Questionnaire**" designed to give the REA-Research Executive Agency feedback on the training/research activities of the fellow.

The fellows were made aware of administrative details and some peculiarities given the fact that the questionnaire has not been designed specifically for a ITN-Innovative Doctoral Program (IDP), like the SoReCom Joint-IDP to which you participate (the EC is aware of this peculiarity and replied that they will take into account that some questions are not applicable in our specific program).









#### **SoReCom Activities and EC Projects News – June 2015**

- Prof. Annamaria Silvana de Rosa chaired the 2015 International Recruitment Board of the European/International Joint PhD in Social Representations and Communication (including Prof. Lilian Negura, Prof. Lorena Gil de Montes and Prof. Andrei Holman as representatives respectively from Ottawa University, University of Pais Vasco and AliCuza, lasi University). The three conference calls via Skype on the 8th, 12th and 22<sup>nd</sup> of June 2015, also included interviews with the applicants for the a.y. 2015- selected at the first step on the basis of the dossier evaluation, after the eligibility criteria check. Beside the fellowship funded by Sapienza University (Italy), the University of Ottawa (Canada), the University of Pais Vasco (Spain) and the University Ali.Cuza, lasi (Romania) have contributed to ensure the sustainability of the joint doctorate according to the criteria established by the MIUR for the yearly accreditation of the program, obtaining for the a.y. 2015-16 six funded positions for the recruited candidates, even supported by external funding agencies like CAPES (Brazil) and CONACYT (México).
- The Mid-term report, including a detailed description of the activities carried out during this first 21 months of activities since October 1 2013 and the Project Deliverables up to 17 June 2015 has been sent to the European Commission.
- A meeting dedicated to the international mobility of PhD trainees took place on the 22<sup>nd</sup> of June 2015, at Sapienza University of Rome, with the presence of Prof. Annamaria Silvana de Rosa and other directors of Sapienza doctoral programs and doctoral schools.
- All the four Projects proposals submitted in the Horizon 2020 have been evaluated between "very good" and "good", exceeding the threshold (70/100), but not financed:
  - the Project SoReCom 2.0-EJD submitted in the call H2020-MSCA-ITN-2014 has exceeded the threshold of 70/100 obtaining 84,00/100 as total score and positioned in the reserve list
  - the Project PORESI submitted in the call H2020-MSCA-IF-2014 has exceeded the threshold of 70/100 obtaining 82,40/100 as total score
  - the Project SoReCom 'iii' Joint-DP submitted in the call H2020-MSCA-COFUND-2014 - has exceeded the threshold of 70/100 obtaining 80,00/100 as total score
  - the Project SoReCom 2.0-EJD submitted in the call **H2020-MSCA-ITN-2015** has exceeded the threshold of 70/100 obtaining 76.80/100 as total score.

Given the very low success rate of about 7% for ITN, the evaluations received by all the four projects can be considered successful and the project leader prof. Annamaria de Rosa thanks once again all the associated partners, who unanimously have appreciated the big investment of energies dedicated for the participation in the increasing hypercompetitive EC calls.

New concerted actions for ensuring the long term sustainability of the program should be pursued valorizing the shared collaborative nature of this Joint Doctorate, which still is the most well-established worldwide and "unique" international interdisciplinary and intersectoral (triple i) doctorate in the field of Social Representations and Communication.






#### Workshop dedicated to Moscovici at Sorbonne-June 2015


