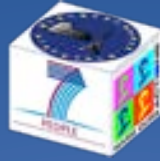
15th Symposium on the Contributions of Psychology to Peace “Bridging Across Generations: Turning Research into Action for Children and Families” Florence and Rome, 21-27 May 2017

The 15th global symposium on the Contributions of Psychology to Peace has been hosted in Italy from the 21st to the 27th of May 2017. The symposium has been jointly organised by the Department of Communication and Social Research, Sapienza University of Rome and the UNICEF Office of Research – Innocenti. The event is part of biennial international symposia series, which was initiated in 1988 by the International Union of Psychological Science, and continues to be coordinated by the Committee for the Psychological Study of Peace (CPSP).

The theme chosen for the 15th symposium was **“Bridging Across Generations: Turning Research into Action for Children and Families”**.

The program examined pressing research issues for children, families and societies, and focused on how to leverage findings to make the most of them in programming, policy and advocacy and bring about change at all levels for children and families. The programme also included a number of experiences and encounters with practitioners and organisation operating in Italy, including C.I.S.O.M. (Corpo Italiano di Soccorso dell'Ordine di Malta/ Order of Malta Italian Relief Agency), Rondine Citta della Pace, Libera, Associazione Progetto Accoglienza, Villaggio La Brocchi. To enrich the cultural experiences of peace and conflict, the program also included visits to historical places of significance to peace and conflict such as Ara Pacis in Rome, and Assisi.

The symposium brought together **68 international experts**, participants and guest speakers to address a broad range of issues including the European “refugee crisis”, children and families escaping from instability and extremism, victimization and inter-group contact, emerging citizenships, shared knowledge and family narratives, resilience and prosociality in families and children, humanitarian efforts, peace education and sustainable development. In true peace psychology spirit, the aim is also to go beyond purely academic exchange and to build an international community that promotes peace-related research and action.

Scholars from the ‘Social Representations’ community were involved in the organisation of the symposium both as site coordinators (**Mauro Sarrica**) and scientific committee (**Giovanna Leone, Bruno Mazzara**), and contributed with their research to the scientific meeting.



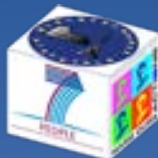

Dorra Ben Alaya presented a contribution entitled “**Cleavage lines and consensus in social order and experienced situation representations among young Tunisians**”. Assuming that the Tunisian young population could be constituted of very contrasted groups concerning their experienced problems and social order vision, the study aimed to identify the cleavage lines that would distinguish these groups at the social representations level. Results show that issues related to the social order foundation give rise to irreconcilable conceptions among young people. Current issues such as illegal immigration could thus be interpreted from a broader societal perspective, including sense of injustice and the perceived lack of recognition and of prospects for the future.

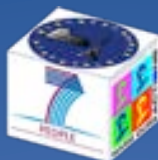

Sara Bigazzi presented a contribution entitled **“Dialogue in play - a sum of field experiences of creating a sense of togetherness”**. The psychological approach adopted highlighted the process of knowledge construction essentially tied to the process of dialogical interaction. Studies and examples were provided showing works on intergroup conflicts that indirectly influence the involved participants micro-contextual roles and deeply rooted societal norms and value system. The importance of structuring dialogue, identity and knowledge representational changes through the co-working for shared aims was highlighted.

Giovanna Leone presented a contribution entitled **“Breaking the silence: Intergenerational narratives about past violence”**. The keynote speech addressed three aims: it disentangled social denial of in-group responsibilities for intergroup violence from other types of silence; it argued that intergenerational narratives which omit information about in-group responsibilities for past violence are highly risky to the descendants of perpetrators; it emphasizes the importance of exploring the moment when a literal social denial about past in-group war crimes is exposed. The study showed that detailed narratives, which take a moral stance on past violence (a strategy that we named, after classic works of Foucault, 1983, parrhesia), provoked a better understanding of information, together with an increase of negative group-based moral emotions.

5th seminar *"Political and economic self-constitution: citizenship identity and education"* *Corinth, 26 May 2017*

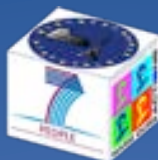

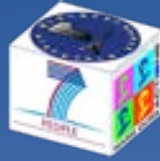

Social Ecology in the Digital Age: Solving Complex Problems in a Globalized World which provides a comprehensive overview of social ecological theory, research, and practice. The book distils key principles from diverse strands of ecological science, offering a robust framework for transdisciplinary research and societal problem-solving. The existential challenges of the 21st Century - global climate change and climate-change denial, environmental pollution, biodiversity loss, food insecurity, disease pandemics, inter-ethnic violence and the threat of nuclear war, cybercrime, the Digital Divide, and extreme poverty and income inequality confronting billions each day - cannot be understood and managed adequately from narrow disciplinary or political perspectives.

Social Ecology in the Digital Age: Solving Complex Problems in a Globalized World will be published by Academic Press/Elsevier in October 2017.

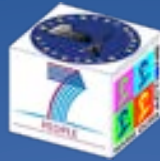
Social Ecology in the Digital Age is grounded in scientific research but written in a personal and informal style from the vantage point of a former student, current teacher and scholar who has contributed over four decades to the field of social ecology. The book will be of interest to scholars, students, educators, government leaders and community practitioners working in several fields including social and human ecology, psychology, sociology, anthropology, criminology, law, education, biology, medicine, public health, earth system and sustainability science, geography, environmental design, urban planning, informatics, public policy and global governance.

The book:

- Traces historical origins and conceptual foundations of biological, human, and social ecology
- Offers a new conceptual framework that brings together earlier approaches to social ecology and extends them in novel directions
- Highlights the interrelations between four distinct but closely intertwined spheres of human environments: our natural, built, sociocultural, and virtual (cyber-based) surroundings
- Spans local to global scales and individual, organizational, community, regional, and global levels of analysis
- Applies core principles of social ecology to identify multi-level strategies for promoting personal and public health, resolving complex social problems, managing global environmental change, and creating resilient and sustainable communities
- Underscores social ecology's vital importance for understanding and managing the environmental and political upheavals of the 21st Century
- Highlights descriptive, analytic, and transformative (or moral) concerns of social ecology
- Presents strategies for educating the next generation of social ecologists emphasizing transdisciplinary, team-based, translational, and transcultural approaches

The book “**Investigaciones en representaciones sociales en la Argentina: problemas teóricos y producción empírica**” has been recently published by Universidad Nacional de Quilmes by the great initiative of our Argentinian colleagues and friends **María Cristina Chardón, Noemí Graciela Murekian and Héctor Scaglia**.

In the Preface, **Denise Jodelet** emphasizes:

- The coherence of the choice of research objects that refer to socially problematic situations and inscribed in history;
- The evocation of human rights commitments that are expected to be effective, but which clash with the institutional and social functioning that contravene them;
- The putting into opposition of principles and values, in relation to concrete cases and its consequence on the lived and the representations of the subjects;
- The epistemological reflection that touches on what is expected of the theory of social representations, are aspects that lead the germ of innovative elements for the approach of social representations.

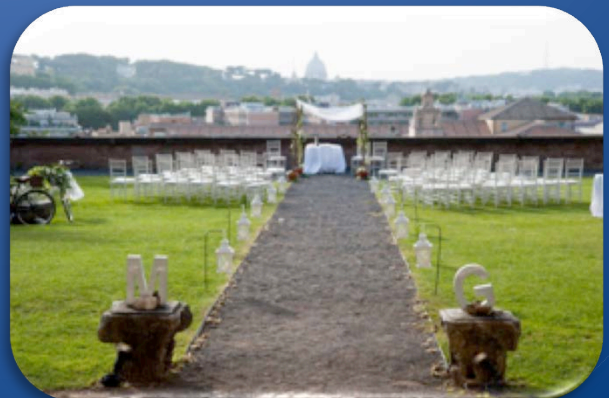

“Different perspectives on the same issues: discourse and interdisciplinarity” is the theme of the upcoming Sixth International Colloquium “Discourse, Representations, Argumentation”, sponsored by **Communalis** - International Communication and Natural Logic Society.

Reaching consensus on the status of discursive objects with regards to language and its relationships with thought processes through communication seems quite unlikely. The surprising crossing of multiple methods of analysis in many non-mathematical disciplines that came to light since the nineteenth century (sociology, psychology, education, communication, language sciences, etc.) only further complicates the resolution of this issue. However, one must admit that most approaches –rooted in the problem of inter, multi or transdisciplinarity– converge towards the core question of making sense of 'discourse' which, on the one hand, gradually moves away from its attachment to the notion of 'text' as being engendered by the verbal-oral couple and, on the other, go on the direction of discursive multimedialization. This is the complex debate that Communalis wants to encourage during the 2017 colloquium.
